1.8 paragraph (b); and 152.023, subdivision 2, paragraph (b).

1.12 Subd. 16. **Small amount.** "Small amount" as applied to marijuana means 42.5
1.13 grams or less. This provision shall not apply to the resinous form of marijuana. The
1.14 weight of water used in a bong, or water pipe, or otherwise used in a controlled substance
1.15 filtration device, may not be considered in determining a small amount except in cases
1.16 where the marijuana is mixed with four or more fluid ounces of water.

3.3 or methamphetamine;

3.4 (2) on one or more occasions within a 90-day period the person unlawfully possesses
3.5 one or more mixtures of a total weight of ten grams or more containing a narcotic drug
3.6 other than cocaine, heroin, or methamphetamine;

3.7 (3) on one or more occasions within a 90-day period the person unlawfully possesses
3.8 one or more mixtures containing a narcotic drug, it is packaged in dosage units, and
3.9 equals 50 or more dosage units;

3.10 (4) on one or more occasions within a 90-day period the person unlawfully
3.11 possesses any amount of a schedule I or II narcotic drug or five or more dosage
