1.2 Page 2, line 21, delete "2015" and insert "2014"

1.3 Page 2, line 34, delete "2015" and insert "2014"

1.4 Page 3, delete section 3 and insert:

1.5 "Sec. 3. Minnesota Statutes 2012, section 477A.0124, is amended by adding a
1.6 subdivision to read:

1.7 Subd. 3a. Use of proceeds. A county that receives a distribution under subdivision
1.8 3, paragraph (b), must use the proceeds solely to prevent the introduction of or limit
1.9 the spread of aquatic invasive species at all access sites within the county. The county
1.10 must establish, by resolution or through adoption of a plan, guidelines for the use of
1.11 the proceeds. The guidelines set by the county board may include, but are not limited
1.12 to, providing for site-level management, countywide awareness, and other procedures
1.13 that the county finds necessary to achieve compliance. The county may appropriate the
1.14 proceeds directly, or may use any portion of the proceeds to provide funding for a joint
1.15 powers board or cooperative agreement with another political subdivision, a soil and water
1.16 conservation district in the county, a watershed district in the county, or a lake association
1.17 located in the county. Any money appropriated by the county to a different entity or
1.18 political subdivision must be used as required under this section.

1.19 For purposes of this section, "aquatic invasive species" means nonnative aquatic
1.20 organisms that invade water beyond their natural and historic range.

1.21 **EFFECTIVE DATE.** This section is effective for aids payable in calendar year
1.22 2014 and thereafter."

1.23 Page 3, line 33, after the period, insert "Notwithstanding section 477A.015, the first
1.24 installment of aid payable in 2015 under this paragraph shall be made on March 15, 2015,
1.25 and the second installment shall be made on July 20, 2015."

1.26 Page 4, after line 2, insert:

2.1 "Sec. 5. **2014 SUPPLEMENTAL PAYMENT FOR AQUATIC INVASIVE**
2.2 **SPECIES PREVENTION AID; APPROPRIATION.**

2.3 (a) For aids payable in 2014 only, the total aid payable under Minnesota Statutes,
2.4 section 477A.0124, subdivision 3, paragraph (b), is \$5,000,000.

2.5 (b) Payment to the counties of the amounts determined under Minnesota Statutes,
2.6 section 477A.0124, subdivision 3, paragraph (b), must be made by the commissioner
2.7 of revenue from the general fund at the time provided in Minnesota Statutes, section
2.8 477A.015 for the first installment of local government aid.

2.9 (c) \$5,000,000 is appropriated from the general fund to the commissioner of revenue
2.10 in fiscal year 2015 to make the aid payments under this section.

2.11 **EFFECTIVE DATE.** This section is effective for aids payable in 2014 only."
