1.4 Subd. 2. **Members; duties.** The majority leader of the senate or a designee, the  
1.5 minority leader of the senate or a designee, the chair of the senate Committee on Finance,  
1.6 and the chair of the appropriate finance committee, or division of the senate ~~Division of~~  
1.7 ~~Finance~~ responsible for overseeing the items being considered by the commission, the  
1.8 ranking minority member of the appropriate finance committee, or division of the senate  
1.9 responsible for overseeing the items being considered by the commission, the speaker of  
1.10 the house or a designee, the minority leader of the house of representatives or a designee,  
1.11 the chair of the house of representatives Committee on Ways and Means, ~~and~~ the chair of  
1.12 the appropriate finance committee, or division of the house of representatives committee  
1.13 responsible for overseeing the items being considered by the ~~commissioner,~~ commission,  
1.14 and the ranking minority member of the appropriate finance committee, or division of the  
1.15 house of representatives committee responsible for overseeing the items being considered  
1.16 by the commission constitute the Legislative Advisory Commission. The division chair  
1.17 and ranking minority member of the Finance Committee in the senate and the division  
1.18 chair and ranking minority member of the appropriate finance committee or division in  
1.19 the house of representatives shall rotate according to the items being considered by the  
1.20 commission. If any of the members elect not to serve on the commission, the house of  
1.21 which they are members, if in session, shall select some other member for the vacancy.  
1.22 If the legislature is not in session, vacancies in the house of representatives membership  
1.23 of the commission shall be filled by the last speaker of the house or, if the speaker is not  
1.24 available, by the last chair of the house of representatives Rules Committee, and by the last  
1.25 senate Committee on Committees or other appointing authority designated by the senate  
1.26 rules in case of a senate vacancy. The commissioner of management and budget shall be  
1.27 secretary of the commission and keep a permanent record and minutes of its proceedings,

2.1 which are public records. The commissioner of management and budget shall transmit,  
2.2 under section 3.195, a report to the next legislature of all actions of the commission.  
2.3 Members shall receive traveling and subsistence expenses incurred attending meetings  
2.4 of the commission. The commission shall meet from time to time upon the call of the  
2.5 governor or upon the call of the secretary at the request of two or more of its members. A  
2.6 recommendation of the commission must be made at a meeting of the commission unless  
2.7 a written recommendation is signed by all the members entitled to vote on the item.
