1.4 **97A.502 DEER KILLED BY MOTOR VEHICLES.**

1.5 (a) Deer killed by a motor vehicle on a public road must be removed by the road
1.6 authority, as defined by section 160.02, subdivision 25, unless the driver of the motor
1.7 vehicle is allowed to possess the deer under paragraph (b). The commissioner of natural
1.8 resources must provide to all road authorities standard forms for statistical purposes and
1.9 the tracking of wild animals.

1.10 (b) The driver of a motor vehicle that has collided with and killed a deer on a public
1.11 road has priority for a possession permit for the entire deer if the facts indicate that the
1.12 deer was not taken illegally."

1.13 Page 11, after line 16, insert:

1.14 "Sec. 24. Minnesota Statutes 2008, section 97B.325, is amended to read:

1.15 **97B.325 DEER STAND RESTRICTIONS.**

1.16 A person may not take deer from a constructed platform or other structure that is
1.17 located within the right-of-way of an improved public highway ~~or is higher than 16 feet~~
1.18 ~~above the ground. The height restriction does not apply to a portable stand that is chained,~~
1.19 ~~belted, clamped, or tied with rope.~~

1.20 Sec. 25. **97B.4251] BAITING BEAR; USE OF DRUM.**

1.21 Notwithstanding section 97B.425, a private landowner or person authorized by the
1.22 private landowner may use a drum to bait bear on the person's private land. The drum
1.23 must be securely chained or cabled to a tree so that it cannot be moved from the site by a
1.24 bear and the drum may not include a mechanical device for dispensing feed. The drum

2.1 must be marked with the name and address of the person who registered the bait site. For
2.2 purposes of this section, "drum" means a 30 gallon or larger drum."

2.11 Page 13, after line 31, insert:

2.12 "Sec. 33. **[348.125] COYOTE CONFLICT MANAGEMENT OPTION.**

2.13 A county board may, by resolution, offer a bounty for the taking of coyotes (Canis
2.14 latrans) by all legal methods. The resolution may be made applicable to the whole or any
2.15 part of the county. The bounty must apply during the months specified in the resolution
2.16 and be in an amount determined by the board.

2.17 **EFFECTIVE DATE.** This section is effective the day following final enactment."

2.18 Page 13, delete section 29, and insert:

2.19 "Sec. 34. **REPEALER.**

2.20 Minnesota Statutes 2008, sections 84.942, subdivisions 2, 3, and 4; 97A.435,
2.21 subdivision 5; 97B.022, subdivision 1; 97B.511; and 97B.515, subdivision 3, are repealed."
