1.2 Page 3, after line 14, insert:

1.3 "Sec. 3. Minnesota Statutes 2008, section 128C.24, is amended to read:

1.4 **128C.24 LEAGUE FUNDS TRANSFER FINANCIAL ASSISTANCE.**

1.5 **Subdivision 1. Foundation grants; sales tax savings.** Beginning July 1, 2007,  
1.6 the Minnesota State High School League shall annually determine the sales tax savings  
1.7 attributable to section 297A.70, subdivision 11, and annually transfer that amount to  
1.8 a nonprofit charitable foundation created for the purpose of promoting high school  
1.9 extracurricular activities. The funds must be used by the foundation to make grants to  
1.10 fund, assist, recognize, or promote high school students' participation in extracurricular  
1.11 activities. The first priority for funding will be grants for scholarships to individuals to  
1.12 offset athletic fees. The foundation must equitably award grants based on considerations  
1.13 of gender balance, school size, and geographic location, to the extent feasible.

1.14 **Subd. 2. League grants for participation.** Money paid to the league under chapter  
1.15 473J or section 473.5814 must be used to provide need-based financial assistance to  
1.16 Minnesota students who participate in league-sanctioned activities. The league must  
1.17 establish grant program criteria, procedures, and award maximums. If a student is awarded  
1.18 a grant, the league must make it to the school directly and the school must then waive  
1.19 participation fees for that student."

1.20 Page 13, after line 3, insert:

1.21 **"Subd. 2a. Team contribution to student athletics.** In addition to the contribution  
1.22 under subdivision 2, including the fan participation payment, the team must transfer to the  
1.23 Minnesota State High School League under section 128C.24, subdivision 2, an amount  
1.24 equal to five percent of the team contribution under subdivision 2."

1.25 Page 15, line 31, delete "and"

1.26 Page 15, line 33, delete the period and insert "; and"

2.1 Page 15, after line 33, insert:

2.2 "(3) to provide need-based grants to high school students to pay athletic participation  
2.3 fees."

2.4 Page 15, line 34, after "(b)" insert "Except as provided in subdivision 6,"

2.5 Page 18, after line 17, insert:

2.6 "Subd. 6. Minnesota State High School League; student athletic participation  
2.7 fee grants. Before the commissioner pays the proceeds of any taxes imposed under  
2.8 this section to the authority, the commissioner shall remit five percent of the proceeds,  
2.9 including interest and penalties, less refunds and the direct costs of collection, at least  
2.10 quarterly to the Minnesota State High School League for the purposes of section 128C.24,  
2.11 subdivision 2. This money is appropriated to the commissioner for this purpose."

2.12 Page 34, after line 9, insert:

2.13 "Subd. 2a. Team contribution to student athletics. In addition to the contribution  
2.14 under subdivision 2, the team must transfer to the Minnesota State High School League  
2.15 under section 128C.24, subdivision 2, an amount equal to five percent of the amount  
2.16 placed in escrow by the team under subdivision 2."
