1.3 "Sec. 4. Minnesota Statutes 2012, section 169.222, subdivision 2, is amended to read:

1.4 Subd. 2. **Manner and number riding.** No bicycle, including a tandem bicycle,  
1.5 cargo or utility bicycle, or trailer, shall be used to carry more persons at one time than the  
1.6 number for which it is designed and equipped, except ~~(1) on a baby seat attached to the~~  
1.7 ~~bicycle, provided that the baby seat is equipped with a harness to hold the child securely in~~  
1.8 ~~the seat and that protection is provided against the child's feet hitting the spokes of the~~  
1.9 ~~wheel or (2) in a seat attached to the bicycle operator~~ an adult rider may carry a child in a  
1.10 seat designed for carrying children that is securely attached to the bicycle.

1.11 Sec. 5. Minnesota Statutes 2012, section 169.222, subdivision 4, is amended to read:

1.12 Subd. 4. **Riding rules.** (a) Every person operating a bicycle upon a roadway shall  
1.13 ride as close as practicable to the right-hand curb or edge of the roadway except under  
1.14 any of the following situations:

- 1.15 (1) when overtaking and passing another vehicle proceeding in the same direction;
- 1.16 (2) when preparing for a left turn at an intersection or into a private road or driveway;
- 1.17 (3) when reasonably necessary to avoid conditions, including fixed or moving
- 1.18 objects, vehicles, pedestrians, animals, surface hazards, or narrow width lanes, that make
- 1.19 it unsafe to continue along the right-hand curb or edge; or
- 1.20 (4) when operating on the shoulder of a roadway or in a designated bicycle lane.

1.21 (b) If a bicycle is traveling on a shoulder of a roadway, the bicycle shall travel in the  
1.22 same direction as adjacent vehicular traffic.

1.23 (c) Persons riding bicycles upon a roadway or shoulder shall not ride more than two  
1.24 abreast and shall not impede the normal and reasonable movement of traffic and, on a  
1.25 laned roadway, shall ride within a single lane.

2.1 (d) A person operating a bicycle upon a sidewalk, or across a roadway or shoulder  
2.2 on a crosswalk, shall yield the right-of-way to any pedestrian and shall give an audible  
2.3 signal when necessary before overtaking and passing any pedestrian. No person shall ride  
2.4 a bicycle upon a sidewalk within a business district unless permitted by local authorities.  
2.5 Local authorities may prohibit the operation of bicycles on any sidewalk or crosswalk  
2.6 under their jurisdiction.

2.7 (e) An individual operating a bicycle or other vehicle on a bikeway shall leave a safe  
2.8 distance when overtaking a bicycle or individual proceeding in the same direction on the  
2.9 bikeway, and shall maintain clearance until safely past the overtaken bicycle or individual.

2.10 (f) A person lawfully operating a bicycle on a sidewalk, or across a roadway or  
2.11 shoulder on a crosswalk, shall have all the rights and duties applicable to a pedestrian  
2.12 under the same circumstances.

2.13 (g) A person may operate an electric-assisted bicycle on the shoulder of a roadway,  
2.14 on a bikeway, or on a bicycle trail if not otherwise prohibited under section 85.015,  
2.15 subdivision 1d; 85.018, subdivision 2, paragraph (d); or 160.263, subdivision 2, paragraph  
2.16 (b), as applicable.

2.17 Sec. 6. Minnesota Statutes 2012, section 169.222, subdivision 6, is amended to read:

2.18 Subd. 6. **Bicycle equipment.** (a) No person shall operate a bicycle at nighttime  
2.19 unless the bicycle or its operator is equipped with (1) a lamp which emits a white light  
2.20 visible from a distance of at least 500 feet to the front; and (2) a red reflector of a type  
2.21 approved by the Department of Public Safety which is visible from all distances from 100  
2.22 feet to 600 feet to the rear when directly in front of lawful lower beams of headlamps  
2.23 on a motor vehicle.

2.24 (b) No person may operate a bicycle at any time when there is not sufficient light to  
2.25 render persons and vehicles on the highway clearly discernible at a distance of 500 feet  
2.26 ahead unless the bicycle or its operator is equipped with reflective surfaces that shall be  
2.27 visible during the hours of darkness from 600 feet when viewed in front of lawful lower  
2.28 beams of headlamps on a motor vehicle. The reflective surfaces shall include reflective  
2.29 materials on each side of each pedal to indicate their presence from the front or the rear and  
2.30 with a minimum of 20 square inches of reflective material on each side of the bicycle or its  
2.31 operator. Any bicycle equipped with side reflectors as required by regulations for new  
2.32 bicycles prescribed by the United States Consumer Product Safety Commission shall be  
2.33 considered to meet the requirements for side reflectorization contained in this subdivision.

2.34 (c) A bicycle may be equipped with a front lamp that emits a white flashing signal,  
2.35 or a rear lamp that emits a red flashing signal, or both. A bicycle equipped with front and

3.1 rear lamps that are visible from a distance of at least 500 feet from both the front and the  
 3.2 rear shall be deemed to fully comply with this paragraph.

3.3 (d) A bicycle may be equipped with tires having studs, spikes, or other protuberances  
 3.4 designed to increase traction.

3.5 (e) No person shall operate a bicycle unless it is equipped with a rear brake or  
 3.6 front and rear brakes which will enable the operator to make ~~the~~ a braked wheels wheel  
 3.7 skid on dry, level, clean pavement. A bicycle equipped with a direct or fixed gear that  
 3.8 can make the rear wheel skid on dry, level, clean pavement shall be deemed to fully  
 3.9 comply with this paragraph.

3.10 (f) A bicycle may be equipped with a horn or bell designed to alert motor vehicles,  
 3.11 other bicycles, and pedestrians of the bicycle's presence.

3.12 ~~(f)~~ (g) No person shall operate upon a highway any two-wheeled bicycle equipped  
 3.13 with handlebars so raised that the operator must elevate the hands above the level of the  
 3.14 shoulders in order to grasp the normal steering grip area.

3.15 ~~(g)~~ (h) No person shall operate upon a highway any bicycle which is of such a size  
 3.16 as to prevent the operator from stopping the bicycle, supporting it with at least one foot  
 3.17 on the highway surface and restarting in a safe manner.

3.18 Sec. 7. Minnesota Statutes 2012, section 169.68, is amended to read:

3.19 **169.68 HORN, SIREN.**

3.20 (a) Every motor vehicle when operated upon a highway must be equipped with  
 3.21 a horn in good working order and capable of emitting sound audible under normal  
 3.22 conditions from a distance of not less than 200 feet. However, the horn or other warning  
 3.23 device must not emit an unreasonably loud or harsh sound or a whistle. The driver of a  
 3.24 motor vehicle shall, when reasonably necessary to insure safe operation, give audible  
 3.25 warning with the horn, but shall not otherwise use the horn when upon a highway.

3.26 (b) A vehicle must not be equipped with, and a person shall not use upon a vehicle,  
 3.27 any siren, whistle, or bell, except as otherwise permitted in this section.

3.28 (c) It is permissible, but not required, for any commercial vehicle to be equipped  
 3.29 with a theft alarm signal device, so arranged that it cannot be used by the driver as an  
 3.30 ordinary warning signal.

3.31 (d) All authorized emergency vehicles must be equipped with a siren capable of  
 3.32 emitting sound audible under normal conditions from a distance of not less than 500 feet  
 3.33 and of a type conforming to the federal certification standards for sirens, as determined by  
 3.34 the General Services Administration. However, the siren must not be used except when the  
 3.35 vehicle is operated in response to an emergency call or in the immediate pursuit of an actual

4.1 or suspected violator of the law, in which latter events the driver of the vehicle shall sound  
4.2 the siren when necessary to warn pedestrians and other drivers of the vehicle's approach.

4.3 (e) It is permissible, but not required, for a bicycle to be equipped with a horn or bell  
4.4 designed to alert motor vehicles, other bicycles, and pedestrians of the bicycle's presence."
