1.2 (H4382DE4), as follows:

1.3 Page 73, line 25, after the period, insert "If the license holder has a continuous insurance
1.4 policy that renews each year, the license holder may indicate the policy's renewal date in
1.5 the initial written notice to parents, and no further notices are required until the insurance
1.6 coverage changes or the policy lapses."

1.7 Page 76, line 20, before "The" insert "When applicable for the program,"

1.8 Page 88, line 19, before "training" insert "for programs licensed for children younger
1.9 than school age,"

1.10 Page 90, delete subdivision 1 and insert:

1.11 "Subdivision 1. **Initial training; helper.** (a) Before assisting in care, a helper who assists
1.12 with care must complete a minimum of four hours of training within the previous 12 months.

1.13 The four hours must include courses on:

1.14 (1) reducing the risk of sudden unexpected infant death if the program is licensed to care
1.15 for infants;

1.16 (2) abusive head trauma if the program is licensed to care for children younger than
1.17 school age; and

1.18 (3) reporting suspected maltreatment of children as required under chapter 260E.

1.19 (b) The trainings required under paragraph (a) may be combined in a single
1.20 commissioner-approved course.

1.21 (c) A license holder must maintain written or electronic documentation showing that
1.22 each helper has complied with this subdivision."

2.1 Page 90, line 23, after "death" insert "if the program is licensed to care for infants," and
2.2 after "trauma" insert "if the program is licensed to care for children younger than school
2.3 age"

2.4 Page 90, delete lines 26 and 27 and insert:

2.5 "(b) A license holder must maintain documentation showing each helper has complied
2.6 with this subdivision."

2.7 Page 90, line 28, delete "(b)" and insert "(c)"

2.8 Page 95, line 2, after "materials" insert "that can start a fire or create other safety hazards"

2.9 Page 100, line 3, after the period, insert "The State Building Code allows appropriate
2.10 openings for access to the spaces under this subdivision, such as a doorway or a gate."

2.11 Page 102, delete lines 18 to 32 and insert:

2.12 "(b) Family child care programs that draw water from privately owned wells must test
2.13 the water annually by a Department of Health-certified laboratory for coliform bacteria and
2.14 nitrate nitrogen and receive confirmation that the water is safe. The family child care program
2.15 must submit a copy of the test results with the agency. Retesting and corrective measures
2.16 may be required by the agency if results do not meet state drinking water standards or where
2.17 the supply may be subject to off-site contamination. A copy of the most recent water testing
2.18 results must be kept on the licensed premises. If the water test results are at or above
2.19 Department of Health-recommended levels or if the license holder declines to test the water
2.20 supply in the program, the license holder must:

2.21 (1) supply bottled or packaged water;

2.22 (2) use water filtration devices that have been certified by the National Science
2.23 Foundation or American National Standards Institute to remove the contaminant. The water
2.24 filtration device must be attached directly to water faucets, inserted into the refrigerator
2.25 water dispenser, or inserted into water pitchers or bottles. The water filtration device must
2.26 be maintained according to manufacturer guidelines; or

2.27 (3) close the family child care program to prevent children from using or consuming
2.28 unsafe water."

2.29 Page 103, delete lines 1 and 2

2.30 Page 103, after line 14, insert:

2.31 "(d) The notification requirements under this subdivision may be met by posting the
2.32 form in a prominent place."

3.1 Page 107, delete lines 21 and 22 and insert:

3.2 "(b) License holders of programs that serve infants are encouraged to monitor sleeping
3.3 infants by conducting in-person checks on each infant in the license holder's care every 30
3.4 minutes.

3.5 (c) Upon enrollment of an infant, the license holder is encouraged to conduct in-person
3.6 checks on the sleeping infant every 15 minutes during the first four months of care.

3.7 (d) When an infant has an upper respiratory infection, the license holder is encouraged
3.8 to conduct in-person checks on the sleeping infant every 15 minutes throughout the hours
3.9 of sleep."

3.11 Page 108, line 28, after "caregiver" insert "on the child care emergency plan" and after
3.12 "and" insert "document this training. The information must be reviewed at least annually
3.13 and updated when information changes."

3.14 Page 108, delete line 29

3.15 Page 109, line 21, after "fire" insert "and storm"

3.16 Page 109, line 22, after "fire" insert "and storm"

3.17 Page 110, line 24, after "children" insert ". Licensed animal exhibitions, such as mobile
3.18 petting zoos, reptile shows, and educational presentations are exempt from this clause with
3.19 written parental notice and consent"

3.20 Page 113, line 29, after the first "the" insert "following" and delete everything after
3.21 "requirements" and insert a colon

3.22 Page 113, delete lines 30 and 31 and insert:

3.23 "(1) breakfast must contain at least three of the following:

3.24 (i) pasteurized milk or milk alternatives;

3.25 (ii) vegetables;

3.26 (iii) fruit; or

3.27 (iv) grains;

3.28 (2) lunch and dinner must contain at least four of the following:

3.29 (i) pasteurized milk or milk alternatives;

3.30 (ii) meat or meat alternatives;

- 4.2 (iv) fruit; or
- 4.3 (v) grains; and
- 4.4 (3) snacks must contain at least two of the following:
