Fiscal Year 2023 Structural Gap

Current General Fund structural gap is \$74.9 million

 FY2013-2022 enrollment trends and past funding levels are primary drivers of current status

Fiscal Year 2023 Structural Gap

- Colleges and universities in process of addressing this with
 - One-time compensation savings
 - Reductions in operating expenses
 - Delayed investments
 - Utilizing reserves
- Remaining federal Higher Education Emergency Relief Fund (HEERF) funding will be a significant offset to the remaining gap for many colleges

Fiscal Years 2024 and 2025

- Colleges and universities updated their enrollment projections on February 1, 2023, and their budget projections on February 9, 2023.
- Each institution is at a different point in the process of shortterm and long-term budget planning. Some institutions have already implemented multi-year budget reductions based on changes in enrollment.
- System budget request is intended to address inflationary increases in personnel and non-personnel costs.
- For this model, FY24 and FY25 employee compensation assumptions are based on the availability of new campus revenue in the system's request.
