3.13 limits that are more stringent than secondary treatment, the maximum award under this

3.16 "Sec. 6. **LEAD SERVICE LINE REPLACEMENT; APPROPRIATION.**

3.17 Subdivision 1. Definitions. (a) For the purposes of this section, the following terms have
3.18 the meanings given.

3.19 (b) "Community water system" has the meaning given in United States Code, title 42,
3.20 section 300f(15).

3.21 (c) "Lead service line" means a water supply connection that is made of or lined with a
3.22 material consisting of lead and that connects a water main to a building. A lead pigtail, lead
3.23 gooseneck, or other lead fitting shall be considered a lead service line, regardless of the
3.24 composition of the service line or other portions of piping to which the piece is attached.
3.25 A galvanized service line shall be considered a lead service line.

3.26 (d) "Service line" means any piping, tubing, or fitting connecting a water main to a
3.27 building. Service line includes the property owner side and the system side of a service line.

3.28 (e) "System side" means the portion of a service line that is owned by a community
3.29 water system.

3.30 Subd. 2. Appropriation. \$2,335,000 in fiscal year 2023 is appropriated from the general
3.31 fund to the Metropolitan Council for grants to cities and other entities operating community

4.1 water systems to replace the privately owned portion of residential lead service lines. Grants
4.2 from this appropriation must first be used to supplement any federal money provided to the
4.3 state as principal forgiveness or grants under Public Law 117-58, the Infrastructure
4.4 Investment and Jobs Act, to cover 100 percent of the cost to replace privately owned
4.5 residential lead service lines.

4.6 Subd. 3. **Eligibility.** Grants awarded under this section must be used to replace or partially
4.7 replace lead service lines within census tracts where at least three of the following apply

4.18 Subd. 4. **Prevailing wage.** Laborers and mechanics performing work on a project funded
4.19 by a grant under this section, including removal and replacement of lead service lines and
4.20 installation of replacement lead service lines, must be paid the prevailing wage rate for the
4.21 work as defined in Minnesota Statutes, section 177.42, subdivision 6. The project is subject
4.22 to the requirements and enforcement provisions of Minnesota Statutes, sections 177.30 and
4.23 177.41 to 177.45."
