Sec. 4. SCHOOL TREE PLANTING GRANTS; APPROPRIATION.

\$1,000,000 in fiscal year 2024 is appropriated from the general fund to the commissioner of natural resources for grants to schools, including public and private schools, to plant trees on school grounds while providing hands-on learning opportunities for students. A grant application under this section must be prepared jointly with the parent-teacher organization or similar parent organization for the school.

Sec. 5. MINNEAPOLIS PARK AND RECREATION BOARD; APPROPRIATION.

\$1,000,000 in fiscal year 2024 is appropriated from the general fund to the commissioner of natural resources for a grant to the Minneapolis Park and Recreation Board to plant trees within its parks, including, but not limited to converting ash stands to more diverse and climate-adapted species and to replace removed ash trees."
