2.5 (a) \$634,000 the first year and \$634,000 the
 2.6 second year are for the continuation of the
 2.7 dairy development and profitability
 2.8 enhancement program, including dairy
 2.9 profitability teams and dairy business planning
 2.10 grants under Minnesota Statutes, section
 2.11 32D.30.

2.12 (b) The commissioner may use funds
 2.13 appropriated in this subdivision for annual
 2.14 cost-share payments to resident farmers or
 2.15 entities that sell, process, or package
 2.16 agricultural products in this state for the costs
 2.17 of organic certification. The commissioner
 2.18 may allocate these funds for assistance to
 2.19 persons transitioning from conventional to
 2.20 organic agriculture.

2.21 (c) \$100,000 the first year and \$100,000 the
 2.22 second year are for mental health outreach and
 2.23 support to farmers, ranchers, farm workers
 2.24 and employees, and others in the agricultural
 2.25 community and profession and for farm and

 2.28 17.1195. Mental health outreach and support
 2.29 may include a 24-hour hotline, stigma
 2.30 reduction, and education. Notwithstanding

 2.32 unencumbered balance does not cancel at the
 2.33 end of the first year and is available in the
 2.34 second year. The base for this appropriation

3.1 is \$50,000 in fiscal year 2028 and each year
3.2 thereafter.

3.3 (d) \$700,000 the first year and ~~\$700,000~~
3.4 \$2,450,000 the second year are for the local
3.5 food purchasing assistance grant program
3.6 under article 3, section 35. Notwithstanding
3.7 Minnesota Statutes, section 16A.28, any
3.8 unencumbered balance does not cancel at the
3.9 end of the first year and is available in the

3.11 (e) \$18,257,000 the first year and \$18,007,000

3.17 (f) Except as provided in paragraph (g), the
3.18 commissioner may allocate the appropriation

3.20 following areas: facilitating the startup,

3.22 livestock operations, including beginning and
3.23 transitioning livestock operations with
3.24 preference given to robotic dairy-milking
3.25 equipment; assisting value-added agricultural

3.27 markets, or to diversify, including aquaponics
3.28 systems, with preference given to hemp fiber
3.29 processing equipment; facilitating the startup,

4.23 (1) \$1,000,000 the first year and \$1,000,000
4.24 the second year are for distribution in equal
4.25 amounts to each of the state's county fairs to
4.26 preserve and promote Minnesota agriculture;

4.27 (2) \$3,000,000 the first year and \$3,000,000
4.28 the second year are for incentive payments
4.29 under Minnesota Statutes, sections 41A.16,
4.30 41A.17, 41A.18, and 41A.20. If this
4.31 appropriation exceeds the total amount for
4.32 which all producers are eligible in a fiscal
4.33 year, the balance of the appropriation is
4.34 available for other purposes under this
4.35 paragraph;

5.1 (3) \$2,750,000 the first year and \$2,750,000
5.2 the second year are for grants that enable retail
5.3 petroleum dispensers, fuel storage tanks, and
5.4 other equipment to dispense biofuels to the
5.5 public in accordance with the biofuel
5.6 replacement goals established under
5.7 Minnesota Statutes, section 239.7911. A retail
5.8 petroleum dispenser selling petroleum for use
5.9 in spark ignition engines for vehicle model
5.10 years after 2000 is eligible for grant money
5.11 under this clause if the retail petroleum
5.12 dispenser has no more than 20 retail petroleum
5.13 dispensing sites and each site is located in
5.14 Minnesota. The grant money must be used to
5.15 replace or upgrade equipment that does not
5.16 have the ability to be certified for E25. A grant
5.17 award must not exceed 65 percent of the cost
5.18 of the appropriate technology. A grant award
5.19 must not exceed \$200,000 per station. The
5.20 commissioner must cooperate with biofuel
5.21 stakeholders in the implementation of the grant
5.22 program. The commissioner, in cooperation
5.23 with any economic or community development
5.24 financial institution and any other entity with
5.25 which the commissioner contracts, must
5.26 submit a report on the biofuels infrastructure
5.27 financial assistance program by January 15
5.28 each year to the chairs and ranking minority
5.29 members of the legislative committees and
5.30 divisions with jurisdiction over agriculture
5.31 policy and finance. The annual report must
5.32 include but not be limited to a summary of the

6.8 startup, modernization, or expansion of meat,
6.9 poultry, egg, and milk processing facilities. A
6.10 grant award under this clause must not exceed
6.11 \$200,000;

6.12 (5) \$1,594,000 the first year and \$1,544,000
6.13 the second year are for providing more fruits,
6.14 vegetables, meat, poultry, grain, and dairy for
6.15 children in school and early childhood
6.16 education settings, including, at the
6.17 commissioner's discretion, providing grants
6.18 to reimburse schools and early childhood
6.19 education and child care providers for
6.20 purchasing equipment and agricultural
6.21 products. Of the amount appropriated,
6.22 \$150,000 each year is for a statewide
6.23 coordinator of farm-to-institution strategy and
6.24 programming. The coordinator must consult
6.25 with relevant stakeholders and provide
6.26 technical assistance and training for
6.27 participating farmers and eligible grant
6.28 recipients. The base for this appropriation is
6.29 \$1,636,000 in fiscal year 2028 and each year
6.30 thereafter. At the commissioner's discretion,
6.31 for state administration of federal cooperative
6.32 agreements for purchasing Minnesota grown
6.33 and raised foods for schools, child care
6.34 providers, food banks, and other institutions,
6.35 the commissioner may use an amount of state

7.3 commissioner shall expend any available

7.17 (8) up to \$200,000 the first year and up to
7.18 \$200,000 the second year are for cooperative
7.19 development grants under Minnesota Statutes,
7.20 section 17.1016;

7.21 (9) \$250,000 the first year and \$150,000 the
7.22 second year are for the protecting livestock
7.23 grant program for producers to support the
7.24 installation of measures to prevent the
7.25 transmission of avian influenza. For the
7.26 appropriation in this clause, a grant applicant
7.27 must document a cost-share of 20 percent. An
7.28 applicant's cost-share amount may be reduced
7.29 up to \$2,000 to cover time and labor costs.

7.30 This is a onetime appropriation; and

7.31 (10) up to \$525,000 the first year and up to
7.32 \$525,000 the second year are to award AGRI
7.33 Works grants to institutions and organizations
7.34 to provide regional and statewide services.

8.1 Preference shall be given to legislatively

8.5 promotion, and research and education. A
8.6 grant award under this clause must not exceed
