1.7 2027, the host organization shall prioritize outreach to, collaboration with, and inclusion of  
1.8 businesses that are majority owned by people of color, women, and people with disabilities."

- 2.13 (2) \$1,800,000 in the first year and \$900,000  
2.14 in the second year are for capitalizing a loan  
2.15 program for the development and construction  
2.16 of commercial and residential projects in areas  
2.17 negatively affected by civil unrest. A priority  
2.18 for use of these funds shall be participants in  
2.19 programs for emerging developers."
