2.4 a ~~six~~ 12 percent preference, but no less than the percentage awarded to any other group
2.5 under this section, on state procurement to certified small businesses that are majority-owned
2.6 and operated by veterans.

4.11 choose to authorize a nationally recognized certifying organization if the certification
