Dear Minnesota decision makers,

On behalf of the undersigned organizations, we urge you to support increases to the Farm to School budget in the Agriculture Omnibus Bill, as proposed by H.F. 1940 (Miller) & S.F. 1760 (Goggin).

Our farmers, schools and children are facing an urgent crisis due to the ongoing pandemic, and they need your investment.

Farmers have lost business and faced dire uncertainty of their sales this year. According to the USDA's Economic Research Service, net cash farm income is expected to fall 7.5% in 2021, the first decrease since 2016. This will be driven by a marked decrease in direct government payments related to COVID disaster release and supplemental income payments. Providing new direct markets is one way to ease the transition back to a post-Covid economy.

Farm to School is good for farmers. Farmers growing foods for their local communities is a rapidly growing important area of Minnesota agriculture that needs public support and investment to expand markets. Farm to School gives farmers a large, stable, predictable market that they can plan for in advance. It also allows them to grow value added crops that boost the bottom line and keep more families living on and caring for the land.

COVID-19 has undone the progress MN had made to reduce hunger levels, and today 1 in 9 Minnesotans, including 1 in 6 kids, is facing hunger--a record number we must address.

Farm to School is good for our kids because it gives them access to and knowledge of healthy local foods. The link between the food kids eat and their educational and health outcomes is becoming increasingly clear. Access to fresh, healthy food, starting as young as possible, fuels brain development and shapes food preference over a lifetime.

Farm to School will also help our economy recover. A study out of Oregon showed that for every dollar spent on Farm to School programs, \$2.16 is generated in additional economic activity for the local economy. Our Farm to School bill would not only support farmers directly, it would also give small businesses and entrepreneurs in Greater Minnesota a boost in revitalizing their communities. After most businesses, schools and farmers faced financial hardship this past year due to the pandemic, funding this bill will provide much needed economic help to aid in increased local sales. This will in turn keep money in our local communities.

This Farm to School & Early Care bill is a worthy investment that works for the health of our children, the health of our family farms and the health of our local communities. Especially now, with farmers, schools, kids and communities facing unprecedented need, Minnesotans can easily agree that this

makes sense for our state to support a statewide a farm to school program through our public support and public investment. Please support Farm to School in the Agriculture Omnibus Finance Bill. Recommended language to adopt in the final Agricultural Omnibus Bill:

As the Conference Committee convenes to consider differences in the House and Senate versions of the Omnibus Agriculture Finance Bill (H.F. 1524 and S.F. 958), we wanted you to know the Farm to School and Early Care Stakeholder Group's priorities and concerns.

SUPPORT House Position: Bolster the Farm to School Reimbursement in AGRI (HF 1524, Lines 9.35-10.7)

Farm to School is a critical market pathway that would create opportunities for beginning farmers and allow existing farmers to expand their markets. AGRI's mission is to support innovative markets and farming like Farm to School and Early Care. The current AGRI Farm to School grant funding is set at a pilot level of \$400,000 a year as the MN Department of Agriculture developed their RFP and reimbursement processes and stakeholders have worked to spread the word about this reimbursement grant opportunity to help schools and early cares purchase local food, modeled after successful reimbursement programs working in other states. Increasing this funding is critical to helping Farm to School and Early Care expand. The final bill should include Farm to School and Early Care in AGRI with increased funding to the reimbursement grant program to encourage the expansion of this new initiative.

House Language: providing funding not to exceed \$800,000 each year to develop and enhance farm-to-school markets for Minnesota farmers by providing more fruits, vegetables, meat, grain, and dairy for Minnesota children in school and child care settings including, at the commissioner's discretion, reimbursing schools for purchases from local farmers





