1.6 Page 8, line 2, delete "; and" and insert a period

1.7 Page 8, delete lines 3 to 8

1.8 Page 20, after line 20, insert:

1.9 "(y) \$2,000 the first year is for grants to the
1.10 Minnesota State Poultry Association. This is
1.11 a onetime appropriation. Notwithstanding
1.12 Minnesota Statutes, section 16A.28, any
1.13 unencumbered balance does not cancel at the
1.14 end of the first year and is available for the
1.15 second year.

1.16 (z) \$18,000 the first year and \$18,000 the
1.17 second year are for grants to the Minnesota
1.18 Livestock Breeders Association. This is a
1.19 onetime appropriation.

1.20 (aa) \$47,000 the first year and \$47,000 the
1.21 second year are for grants to the Northern
1.22 Crops Institute to purchase equipment. This
1.23 is a onetime appropriation.

2.1 (bb) \$17,000 the first year and \$17,000 the
2.2 second year are for grants to the Minnesota
2.3 State Horticultural Society. This is a onetime
2.4 appropriation.

2.5 (cc) \$217,000 the first year and \$217,000 the
2.6 second year are for grants to the Center for
2.7 Rural Policy and Development. This is a
2.8 onetime appropriation.

2.9 (dd) \$75,000 the first year and \$75,000 the
2.10 second year are for grants to the Minnesota
2.11 Turf Seed Council for basic and applied
2.12 research. The Minnesota Turf Seed Council
2.13 may subcontract with a qualified third party
2.14 for some or all of the basic or applied research.
2.15 No later than January 15, 2025, the Minnesota
2.16 Turf Seed Council must submit a report
2.17 outlining the use of the grant money and
2.18 related accomplishments to the chairs and
2.19 ranking minority members of the legislative
2.20 committees with jurisdiction over agriculture.
2.21 This is a onetime appropriation. Any
2.22 unencumbered balance does not cancel at the
2.23 end of the first year and is available in the
2.24 second year.

2.25 (ee) \$125,000 the first year and \$125,000 the
2.26 second year are for grants to Greater Mankato
2.27 Growth, Inc., for assistance to
2.28 agriculture-related businesses to promote jobs,
2.29 innovation, and synergy development. This is
2.30 a onetime appropriation."
