

Budget Snapshot

The Commerce Department licenses and regulates more than 20 industries in Minnesota, including energy, financial institutions, insurance, investment securities and real estate.

The Commerce Department's annual operating budget in FY20 was \$66.75 million. The department operated with 336 full-time equivalent (FTE) employees. In FY20, it spent \$22.98 million from the state's General Fund while adding \$144.2 million in revenue to the General Fund.

Commerce administered over \$100 million in pass-through funds and grants in FY20. The largest grant program administered by Commerce is the Low-Income Heating Assistance Program (LIHEAP). In FY20, it provided \$91 million in federal funding for Minnesota's Energy Assistance Program, which directs these funds to utilities and fuel suppliers to help pay the heating bills of low-income Minnesotans so they can stay safe and warm in the winter.



In FY22-23, revenue from Commerce programs is budgeted to add more than \$191 million to the General Fund; Commerce is budgeted to spend \$54.66 million in General Fund appropriations.
