

**The 2004 Legislature amended the Fair Campaign Practices Act in the hopes of resolving more campaign practice claims before Election Day.**

**1**

OAH is doing the job the Legislature intended.

**2**

OAH resolves half (or more) of election law cases before Election Day.

**3**

OAH resolves even the most complicated of these cases within 60 days of filing.

**4**

OAH's process has the lightest touch possible upon candidates and campaigns, consistent with due process.

**5**

There are still campaign practice violations.

**6**

Additional training to local candidates would boost compliance with the law, improve the conduct of campaigns, and reduce the number of disputes in court.
