1.3 "Section 1. Minnesota Statutes 2025 Supplement, section 17.133, subdivision 1, is amended  
1.4 to read:

1.5 Subdivision 1. **Definitions.** (a) For purposes of this section, the following terms have  
1.6 the meanings given.

1.7 (b) "Eligible farmer" means an individual who at the time that the grant is awarded:

1.8 (1) is a resident of Minnesota who intends to acquire farmland located within the state  
1.9 and provide the majority of the day-to-day physical labor and management of the farm;

1.10 (2) grosses no more than \$250,000 per year from the sale of farm products;

1.11 (3) has not, and whose spouse has not, at any time had a direct or indirect ownership  
1.12 interest in farmland; ~~and~~

1.13 (4) is not, and whose spouse is not, a family member of the owner of the farmland that  
1.14 the individual intends to acquire. "Family member" has the meaning given in section  
1.15 267(c)(4) of the Internal Revenue Code; and

1.16 (5) demonstrates knowledge in farming through at least \$1,000 in past farm income,  
1.17 completion of an approved farm business management program, a four-year degree in an  
1.18 agriculture-related field, or at least three years of experience managing a comparable farm.

1.19 (c) "Farm down payment" means an initial, partial payment required by a lender or seller  
1.20 to purchase farmland.

1.21 (d) "Incubator farm" means a farm where:

2.1 (1) individuals are given temporary, exclusive, and affordable access to small parcels  
2.2 of land, infrastructure, and often training, for the purpose of honing skills and launching a  
2.3 farm business; and

2.4 (2) a majority of the individuals farming the small parcels of land grow industrial hemp,  
2.5 cannabis, or one or more of the following specialty crops as defined by the United States  
2.6 Department of Agriculture for purposes of the specialty crop block grant program: fruits  
2.7 and vegetables, tree nuts, dried fruits, medicinal plants, culinary herbs and spices, horticulture  
2.8 crops, floriculture crops, and nursery crops.

2.9 (e) "Limited land access" means farming without ownership of land and:

2.10 (1) the individual or the individual's child rents or leases the land, with the term of each  
2.11 rental or lease agreement not exceeding three years in duration, from a person who is not  
2.12 related to the individual or the individual's spouse by blood or marriage; or

2.13 (2) the individual rents the land from an incubator farm.

2.14 (f) "Limited market access" means the individual has gross sales of no more than  
2.15 \$100,000 per year from the sale of farm products.

2.18 Subd. 2. **Grants.** (a) The commissioner may award farm down payment assistance grants  
2.19 of up to ~~\$20,000~~ 40 percent of the purchase price of the farm, with a maximum grant of  
2.20 \$30,000 per eligible farmer. Each award must be matched with at least \$8,000 of other  
2.21 funding. Grants under this subdivision may be awarded by a randomized selection process  
2.22 after applications are collected over a period of no less than 30 calendar days. An eligible  
2.23 farmer must commit to own and farm the land purchased with assistance provided under  
2.24 this section for at least five years. For the first five years, each recipient must verify gross  
2.25 farm income of at least \$1,000 or show investment of at least \$1,000 in farm business  
2.26 infrastructure, equipment, perennial crops, or livestock. For each year that a grant recipient  
2.27 does not own and farm the land during the five-year period, the grant recipient must pay a  
2.28 penalty to the commissioner equal to 20 percent of the grant amount.

2.29 (b) If the farmland is located in an area zoned for commercial use, the eligible farmer  
2.30 must submit a business plan with the application. If the farmland is located within the  
2.31 boundaries of a statutory or home rule charter city, the eligible farmer must earn an annual  
2.32 farm revenue of at least \$1,000.

3.6 second year are for payments to county and  
3.7 district agricultural societies and associations  
3.8 under Minnesota Statutes, section 38.02,  
3.9 subdivision 1. Aid payments to county and  
3.10 district agricultural societies and associations  
3.11 must be disbursed no later than July 15 each  
3.12 year. These payments are the amount of aid

5.15 (f) \$1,000,000 the first year and \$1,000,000

6.8 planning, tax preparation, estate planning, and

6.23 entity that is not a for-profit entity to conduct  
6.24 a study of market and workforce factors that  
6.25 may contribute to the incorrect marking for  
6.26 the installation of underground  
6.27 telecommunications infrastructure that is  
6.28 located within ten feet of existing underground  
6.29 utilities or that crosses the existing  
6.30 underground utilities. The study must include  
6.31 recommendations to the legislature and be  
6.32 submitted to the chairs and ranking minority  
6.33 members of the legislative committees and

7.7 practices include: the right source of nutrients,  
7.8 at the right rate and right time, in the right  
7.9 place.

7.11 evaluate strategies for leveraging cost-share  
7.12 programs, including the feasibility of  
7.13 coordinating with the Agricultural Water  
7.14 Quality Certification Program and other efforts

7.17 (2) The commissioner must submit a report
