6.24 Section 1. **[135A.062] CONSIDERATION OF CRIMINAL RECORDS LIMITED.**

6.25 Subdivision 1. **Applicability.** This section applies to postsecondary institutions under
6.26 section 136A.155, except that the Board of Regents of the University of Minnesota is
6.27 requested to comply with this section.

6.28 Subd. 2. **Definition.** As used in this section, "a violent felony or sexual assault" includes
6.29 a felony-level violation or attempted violation of section 609.185; 609.19; 609.195; 609.20;
6.30 609.221; 609.2242, subdivision 4; 609.2247; 609.245, subdivision 1; 609.247, subdivision
6.31 2; 609.282; 609.322; 609.342; 609.343; 609.344; 609.345; 609.3451; 609.3458; 609.561,
6.32 subdivision 1 or 2; 609.582, subdivision 1; 609.66, subdivision 1e; or 609.749; or a statute

7.1 from another state, the United States, or a foreign jurisdiction, in conformity with any of
7.2 these sections.

7.3 Subd. 3. **Consideration of criminal records limited.** A postsecondary institution may
7.4 not inquire into, consider, or require disclosure of the criminal record or criminal history
7.5 of an applicant for admission. After a postsecondary institution has made an offer of
7.6 admission, the postsecondary institution may inquire into, consider, or require disclosure
7.7 of a conviction or delinquency adjudication that occurred within the previous five years for
7.8 a violent felony or sexual assault. The postsecondary institution must provide the applicant
7.9 with an opportunity to submit an explanatory statement, letters of recommendation, evidence
7.10 of rehabilitation, and any other supporting documents. The institution must provide clear
7.11 and detailed instructions and guidance to applicants related to what criminal history requires
7.12 disclosure. The institution must not require the applicant to provide official records of
7.13 criminal history. A postsecondary institution that rescinds an offer of admission must:

7.14 (1) provide an explanation of the basis for the decision to rescind the offer of admission;
7.15 and

7.16 (2) provide the applicant with an opportunity to appeal the decision to rescind.

7.17 Subd. 4. **Other information.** This section shall not prohibit or limit a postsecondary
7.18 institution from inquiring about student conduct records at the applicant's prior postsecondary
7.19 institution after making an offer of admission. This section shall not prohibit or limit a
7.20 postsecondary institution from inquiring about a student's ability to meet licensure
7.21 requirements in a professional program after making an offer of admission.

7.22 Subd. 5. **Limitation on admissibility.** (a) A postsecondary institution that complies
7.23 with this section is immune from liability in a civil action arising out of the institution's
7.24 decision to admit a student with a criminal history or the institution's failure to conduct a
7.25 criminal background check.

7.26 (b) Nothing in this section creates or establishes a legal duty upon a postsecondary
7.27 institution to inquire into or require disclosure of the criminal history or criminal convictions
7.28 of a student or an applicant for admission.

8.11 Subdivision 1. Definitions. (a) The terms defined in this subdivision apply to this section.

8.12 (b) "Debt" means any money, obligation, claim, or sum, due or owed, or alleged to be
 8.13 due or owed, from a student. Debt does not include the fee, if any, charged to all students
 8.14 for the actual costs of providing the transcripts.

8.15 (c) "School" means a public institution governed by the Board of Trustees of the
 8.16 Minnesota State Colleges and Universities, private postsecondary educational institution
 8.17 as defined under section 136A.62 or 136A.821, or public or private entity that is responsible
 8.18 for providing transcripts to current or former students of an educational institution.
 8.19 Institutions governed by the Board of Regents of the University of Minnesota are requested
 8.20 to comply with this section.

8.21 (d) "Transcript" means the statement of an individual's academic record, including
 8.22 official transcripts or the certified statement of an individual's academic record provided
 8.23 by a school, and unofficial transcripts or the uncertified statement of an individual's academic
 8.24 record provided by a school.

8.25 Subd. 2. Prohibited practices. (a) A school must not refuse to provide a transcript for
 8.26 a current or former student because the student owes a debt to the school if:

8.27 (1) the debt owed is less than \$1,000;

8.28 (2) the student has entered into and, as determined by the institution, is in compliance
 8.29 with a payment plan with the school;

8.30 (3) the transcript request is made by a prospective employer for the student;

9.1 (4) the school has sent the debt for repayment to the Department of Revenue or to a
 9.2 collection agency, as defined in section 332.31, subdivision 3, external to the institution

9.22 (2) private postsecondary institutions that offer in-person courses on a campus located
 9.23 in Minnesota and which are eligible institutions as defined in section 136A.103, ~~provided~~
 9.24 ~~that a private postsecondary institution with a systemwide enrollment of fewer than 100~~
 9.25 ~~students in the previous academic year is exempt from subdivisions 4 to 10 paragraph (a),~~
 9.26 that are participating in the federal program under Title IV of the Higher Education Act of

10.1 Reimbursement Board and the commissioner of public safety. The policy must apply to
 10.2 students and employees and must provide information about their rights and duties. The
 10.3 policy must apply to criminal incidents against a student or employee of a postsecondary
 10.4 institution occurring on property owned or leased by the postsecondary system or institution
 10.5 or at any activity, program, organization, or event sponsored by the system or institution,
 10.6 or by a fraternity ~~and~~ or sorority, or any activity, program, organization, or event sponsored
 10.7 by the system or institution, or by a fraternity or sorority, regardless of whether the activity,
 10.8 program, organization, or event occurs on or off property owned or leased by the
 10.9 postsecondary system or institution. It must include procedures for reporting incidents of
 10.10 sexual ~~harassment or sexual violence~~ misconduct and for disciplinary actions against
 10.11 violators. During student registration, a postsecondary institution shall provide each student
 10.12 with information regarding its policy. A copy of the policy also shall be posted at appropriate

10.16 (b) "Advisor" means a person who is selected by a responding or reporting party to serve

10.20 (c) "Domestic violence" has the meaning giving in section 518B.01, subdivision 2.

10.21 ~~(b)~~ (d) "Incident" means one report of sexual assault misconduct to a postsecondary
 10.22 institution, regardless of the number of complainants included in the report, the number of
 10.23 respondents included in the report, and whether or not the identity of any party is known
 10.24 by the reporting postsecondary institution. Incident encompasses all nonconsensual events
 10.25 included within one report if multiple events have been identified.

10.26 (e) "Intimate partner violence" means any physical or sexual harm or a pattern of any
 10.27 other coercive behavior committed, enabled, or solicited to gain or maintain power and
 10.28 control over a victim, including verbal, psychological, economic, or technological abuse
 10.29 that may or may not constitute criminal behavior against an individual, that may be classified
 10.30 as a sexual misconduct, dating violence, or domestic violence caused by:

10.31 (1) a current or former spouse of the individual; or

10.32 (2) a person in a sexual or romantic relationship with the individual.

11.1 (f) "Nonconsensual dissemination of sexual images" has the meaning given in section

11.3 (g) "Reporting party" means the party in a disciplinary proceeding who has reported
 11.4 being subjected to conduct or communication that could constitute sexual misconduct.

11.5 (h) "Responding party" means the party in a disciplinary proceeding who has been
 11.6 reported to be the perpetrator of conduct or communication that could constitute sexual
 11.7 misconduct.

11.8 ~~(e)~~ (i) "Sexual assault" means rape, sex offenses - fondling, sex offenses - incest, or sex
 11.9 offenses - statutory rape as defined in Code of Federal Regulations, title 34, part 668, subpart

11.11 (j) "Sexual extortion" has the meaning given in section 609.3458.

11.12 (k) "Sex trafficking" has the meaning given in section 609.321, subdivision 7a.

11.13 (l) "Sexual harassment" has the meaning given in section 363A.03, subdivision 43.

11.14 (m) "Sexual misconduct" means an incident of sexual violence, intimate partner violence,
 11.15 domestic violence, sexual assault, sexual harassment, nonconsensual distribution of sexual
 11.16 images, sexual extortion, nonconsensual dissemination of a deepfake depicting intimate
 11.17 parts or sexual acts, sex trafficking, or stalking.

11.18 (n) "Stalking" has the meaning given in section 609.749.

11.19 Subd. 2. **Victims' rights.** (a) The policy required under subdivision 1 shall, at a minimum,
 11.20 require that students and employees be informed of the policy, and shall include provisions
 11.21 for:

11.22 (1) filing criminal charges with local law enforcement officials in ~~sexual assault~~ cases
 11.23 defined as sexual misconduct that may constitute criminal behavior;

11.24 (2) the prompt assistance of campus authorities, at the request of the victim, in notifying
 11.25 the appropriate law enforcement officials and disciplinary authorities of a sexual ~~assault~~
 11.26 misconduct incident;

- 12.20 (12) notice to a sexual ~~assault~~ misconduct victim of the availability of a campus or local
 12.21 program providing ~~sexual assault victim~~ advocacy services and information on free legal
 12.22 resources and services;
- 12.23 (13) notice to a sexual ~~assault~~ misconduct victim of the outcome of any campus
 12.24 disciplinary proceeding concerning a sexual ~~assault~~ misconduct complaint, consistent with
 12.25 laws relating to data practices;
- 12.26 (14) the complete and prompt assistance of campus authorities, at the direction of law
 12.27 enforcement authorities, in obtaining, securing, and maintaining evidence in connection
 12.28 with a sexual ~~assault~~ misconduct incident;
- 12.29 (15) the assistance of campus authorities, at the request of the sexual misconduct victim,
 12.30 ~~in preserving for a sexual assault complainant or victim~~ materials relevant to a campus
 12.31 disciplinary proceeding;

13.1 (16) during and after the process of investigating a complaint and conducting a campus
 13.2 disciplinary procedure, the assistance of campus personnel, in cooperation with the
 13.3 appropriate law enforcement authorities, at a sexual ~~assault~~ misconduct victim's request, in
 13.4 shielding the victim from unwanted contact with the alleged assailant, including transfer of
 13.5 the victim to alternative classes or to alternative college-owned housing, if alternative classes
 13.6 or housing are available and feasible;

13.7 (17) forbidding retaliation, and establishing a process for investigating complaints of
 13.8 retaliation, against sexual ~~assault~~ misconduct victims by campus authorities, the accused,
 13.9 organizations affiliated with the accused, other students, and other employees;

13.10 (18) at the request of the victim, providing students who reported sexual ~~assaults~~
 13.11 misconduct to the institution and subsequently choose to transfer to another postsecondary
 13.12 institution with information about resources for victims of sexual ~~assault~~ misconduct at the
 13.13 institution to which the victim is transferring; and

13.14 (19) consistent with laws governing access to student records, providing a student who
 13.15 reported an incident of sexual ~~assault~~ misconduct with access to the student's description
 13.16 of the incident as it was reported to the institution, including if that student transfers to
 13.17 another postsecondary institution.

13.18 (b) None of the rights given to a student by the policy required by subdivision 1 may be
 13.19 made contingent upon the victim entering into a nondisclosure agreement or other contract
 13.20 restricting the victim's ability to discuss information in connection with a sexual misconduct
 13.21 complaint, investigation, or hearing.

13.22 (c) A nondisclosure agreement or other contract restricting the victim's ability to discuss
 13.23 information in connection with a sexual misconduct complaint, investigation, or hearing
 13.24 may not be used as a condition of financial aid or remedial action.

13.25 **Subd. 2a. Campus investigation and disciplinary hearing procedures.** (a) A
 13.26 postsecondary institution must provide a reporting party an opportunity for an impartial,
 13.27 timely, and thorough investigation of a report of sexual misconduct against a student. If an
 13.28 investigation reveals that sexual misconduct has occurred, the institution must take prompt
 13.29 and effective steps reasonably calculated to end the sexual misconduct, prevent its recurrence,
 13.30 and, as appropriate, remedy its effects.

13.31 (b) Throughout any investigation or disciplinary proceeding, a postsecondary institution
 13.32 must treat the reporting parties, responding parties, witnesses, and other participants in the
 13.33 proceeding with dignity and respect.

14.1 (c) If a postsecondary institution conducts a hearing, an advisor may provide opening
14.2 and closing remarks on behalf of a party or assist with formulating questions to the other
14.3 party or witnesses about related evidence or credibility.

14.4 Subd. 3. **Uniform amnesty.** The sexual ~~harassment and violence~~ misconduct policy
14.5 required by subdivision 1 must include a provision that a witness or victim of an incident
14.6 of sexual ~~assault~~ misconduct who reports the incident in good faith shall not be sanctioned
14.7 by the institution for admitting in the report to a violation of the institution's student conduct
14.8 policy on the personal use of drugs or alcohol.

14.9 Subd. 4. **Coordination with local law enforcement.** (a) A postsecondary institution
14.10 must enter into a memorandum of understanding with the primary local law enforcement
14.11 agencies that serve its campus. The memorandum must be entered into no later than January
14.12 1, 2017, and updated every two years thereafter. This memorandum shall clearly delineate
14.13 responsibilities and require information sharing, in accordance with applicable state and
14.14 federal privacy laws, about certain crimes including, but not limited to, sexual assault. This
14.15 memorandum of understanding shall provide:

14.16 (1) delineation and sharing protocols of investigative responsibilities;

14.25 (c) An institution is exempt from the requirement that it develop a memorandum of
14.26 understanding under this section if the institution and local or county law enforcement
14.27 agencies establish a sexual ~~assault~~ misconduct protocol team to facilitate effective cooperation
14.28 and collaboration between the institution and law enforcement.

14.29 Subd. 5. **Online reporting system.** (a) A postsecondary institution must provide an
14.30 online reporting system to receive complaints of sexual ~~harassment and sexual violence~~
14.31 misconduct from students and employees. The system must permit anonymous reports,
14.32 provided that the institution is not obligated to investigate an anonymous report unless a

15.11 **Subd. 6. Data collection and reporting.** (a) Postsecondary institutions must annually
 15.12 report statistics on sexual ~~assault~~ misconduct. This report must be prepared in addition to
 15.13 any federally required reporting on campus security, including reports required by the Jeanne
 15.14 Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act, United States
 15.15 Code, title 20, section 1092(f). The report must include, but not be limited to, the number
 15.16 of incidents of sexual ~~assault~~ misconduct of each offense listed under the definition in
 15.17 subdivision 1a, reported to the institution in the previous calendar year, as follows:

15.18 (1) the number that were investigated by the institution;

15.19 (2) the number that were referred for a disciplinary proceeding at the institution;

15.20 (3) the number the victim chose to report to local or state law enforcement;

15.21 (4) the number for which a campus disciplinary proceeding is pending, but has not
 15.22 reached a final resolution;

15.23 (5) the number in which the alleged perpetrator was found responsible by the disciplinary
 15.24 proceeding at the institution;

15.25 (6) the number that resulted in any action by the institution greater than a warning issued
 15.26 to the accused;

15.27 (7) the number that resulted in a disciplinary proceeding at the institution that closed
 15.28 without resolution;

15.29 (8) the number that resulted in a disciplinary proceeding at the institution that closed
 15.30 without resolution because the accused withdrew from the institution;

15.31 (9) the number that resulted in a disciplinary proceeding at the institution that closed
 15.32 without resolution because the victim chose not to participate in the procedure; and

16.1 (10) the number of reports made through the online reporting system established in
16.2 subdivision 5, excluding reports submitted anonymously.

16.3 (b) If an institution previously submitted a report indicating that one or more disciplinary
16.4 proceedings was pending, but had not reached a final resolution, and one or more of those
16.5 disciplinary proceedings reached a final resolution within the previous calendar year, that
16.6 institution must submit updated totals from the previous year that reflect the outcome of
16.7 the pending case or cases.

16.8 (c) The reports required by this subdivision must be submitted to the Office of Higher
16.9 Education by October 1 of each year. Each report must contain the data required under
16.10 paragraphs (a) and (b) from the previous calendar year.

16.11 (d) The commissioner of the Office of Higher Education shall calculate statewide numbers
16.12 for each data item reported by an institution under this subdivision. The statewide numbers
16.13 must include data from postsecondary institutions that the commissioner could not publish
16.14 due to federal laws governing access to student records.

16.15 (e) The Office of Higher Education shall publish on its website:

16.16 (1) the statewide data calculated under paragraph (d); and

16.29 individuals as defined by section 13.02, subdivision 12, for the purposes of postsecondary

16.31 subject to chapter 13 must limit access to the data to only the data subject and persons whose
16.32 work assignments reasonably require access.

17.1 (b) Only individuals with explicit authorization from an institution may enter, update,
 17.2 or access electronic data related to an incident of sexual ~~assault~~ misconduct collected,
 17.3 created, or maintained under this section. The ability of authorized individuals to enter,
 17.4 update, or access these data must be limited through the use of role-based access that
 17.5 corresponds to the official duties or training level of the individual and the institutional
 17.6 authorization that grants access for that purpose. All actions in which the data related to an
 17.7 incident of sexual ~~assault~~ misconduct are entered, updated, accessed, shared, or disseminated
 17.8 outside of the institution must be recorded in a data audit trail. An institution shall

17.33 Students must complete such training no later than ten business days after the start of a

 18.15 disability, socioeconomic status, religion, sex, gender identity, sexual orientation, and
 18.16 pregnancy or parenting status.

18.17 Subd. 9. **Student health services.** (a) An institution's student health service providers
 18.18 must screen students for incidents of sexual ~~violence and sexual harassment~~ misconduct.
 18.19 Student health service providers shall offer students information on resources available to
 18.20 victims and survivors of sexual ~~violence and sexual harassment~~ misconduct including
 18.21 counseling, mental health services, and procedures for reporting incidents to the institution.

18.22 (b) Each institution offering student health or counseling services must designate an
 18.23 existing staff member or existing staff members as confidential resources for victims of

 18.26 resource must provide victims with information about locally available resources for victims

19.26 **Subd. 3. Navigators.** An institution of higher education must designate at least one
 19.27 employee of the institution to act as a college navigator for current or incoming students at
 19.28 the institution who are parenting students. The navigator must provide to the students
 19.29 information regarding support services and other resources available to the students at the

19.31 (1) medical and behavioral health coverage and services;

21.11 (b) A Minnesota state college or university shall provide and the University of Minnesota
21.12 is requested to provide reasonable modifications to a pregnant student, including

21.15 (2) are related to the health and safety of the student and the student's unborn child, such
21.16 as allowing the student to maintain a safe distance from substances, areas, and activities
21.17 known to be hazardous to pregnant women or unborn children.

21.18 (c) A Minnesota state college or university must and the University of Minnesota is
21.19 requested to, for reasons related to a student's pregnancy, childbirth, or any resulting medical
21.20 status or condition:

21.21 (1) excuse the student's absence;

21.22 (2) allow the student to make up missed assignments or assessments;

21.23 (3) allow the student additional time to complete assignments in the same manner as the
21.24 institution allows for a student with a temporary medical condition; and

21.25 (4) provide the student with access to instructional materials and video recordings of
21.26 lectures for classes for which the student has an excused absence under this section to the
21.27 same extent that instructional materials and video recordings of lectures are made available

21.30 requested to allow a pregnant or parenting student to:

22.4 (e) If a public college or university provides early registration for courses or programs
 22.5 at the institution for any group of students, the Minnesota state college or university must
 22.6 provide and the University of Minnesota is requested to provide early registration for those

22.8 Subd. 3. **Policy on discrimination.** Each Minnesota state college or university must
