HF 1539 (Lislegard) Modifying timeline for reappraisal of acquired natural resources land

HF 1574 (Anderson) Modifying the first tier valuation limit for agricultural homestead property

HF 1587 (Torkelson) Extending the five-year pooling rule to ten years for redevelopment districts located outside the metropolitan area

HF 1610 (Poston) Authorizing the city of Wadena to impose a local sales and use tax

HF 1614 (Keeler) Authorizing the city of Moorhead to impose a local sales and use tax

HF 1661 (Schultz) Exempting certain property from taxation

HF 1666 (Howard) Authorizing the city of Richfield to use tax increment for certain housing projects
