- 7.19 (i) provides on-site child care during the hours of treatment activity that:
- 7.20 (A) is licensed under chapter 245A as a child care center under Minnesota Rules, chapter
7.21 9503; or
- 7.22 (B) is licensed under chapter 245A and sections 245G.01 to 245G.19; or
- 7.23 (ii) arranges for off-site child care during hours of treatment activity at a facility that is
7.24 licensed under chapter 245A as:

8.28 (f) ~~Subject to federal approval,~~ Substance use disorder services that are otherwise covered
8.29 as direct face-to-face services may be provided via telehealth as defined in section 256B.0625,
8.30 subdivision 3b. The use of telehealth to deliver services must be medically appropriate to
8.31 the condition and needs of the person being served. Reimbursement shall be at the same
8.32 rates and under the same conditions that would otherwise apply to direct face-to-face services.

9.1 (g) For the purpose of reimbursement under this section, substance use disorder treatment
9.2 services provided in a group setting without a group participant maximum or maximum
9.3 client to staff ratio under chapter 245G shall not exceed a client to staff ratio of 48 to one.
9.4 At least one of the attending staff must meet the qualifications as established under this
9.5 chapter for the type of treatment service provided. A recovery peer may not be included as
9.6 part of the staff ratio.

9.7 (h) Payment for outpatient substance use disorder services that are licensed according
9.8 to sections 245G.01 to 245G.17 is limited to six hours per day or 30 hours per week unless
9.9 prior authorization of a greater number of hours is obtained from the commissioner.

9.10 (i) Payment for substance use disorder services under this section must start from the
9.11 day of service initiation, when the comprehensive assessment is completed within the
9.12 required timelines.

9.13 (j) Eligible vendors of peer recovery support services must:

9.14 (1) submit to a review by the commissioner of up to 15 percent of all medical assistance
9.15 and behavioral health fund claims, to determine the medical necessity of peer recovery
9.16 support services, for entities billing for peer recovery support services individually and not
9.17 receiving a daily rate;

9.18 (2) limit an individual client to 14 hours per week for peer recovery support services,
9.19 from an individual provider of peer recovery support services. Additional service hours
9.20 may be authorized at the commissioner's discretion; and

9.21 (3) require authorization for more than 728 hours of peer recovery support services per
9.22 calendar year, for an individual client receiving services.

9.23 (k) Peer recovery support services not provided in accordance with section 254B.052
9.24 are subject to monetary recovery under section 256B.064 as money improperly paid.

9.25 **EFFECTIVE DATE.** This section is effective January 1, 2025.

9.26 **Sec. 8. [254B.052] PEER RECOVERY SUPPORT SERVICES REQUIREMENTS.**

9.27 Subdivision 1. **Peer recovery support services; service requirements.** (a) Peer recovery
9.28 support services are face-to-face interactions between a recovery peer and a client in which
9.29 specific goals identified in an individual recovery plan, treatment plan, or stabilization plan
9.30 are discussed and addressed. Peer recovery support services are provided to promote a
9.31 client's recovery goals, self-sufficiency, self-advocacy, and development of natural supports,
9.32 and to support maintenance of a client's recovery.

10.1 (b) Peer recovery support services must be provided according to an individual recovery
10.2 plan, if provided by a recovery community organization or county; a treatment plan if
10.3 provided in a substance use disorder treatment program under chapter 245G; or a stabilization
10.4 plan if provided by a withdrawal management program under chapter 245F.

10.5 (c) A client receiving peer recovery support services must participate in the services
10.6 voluntarily. Any program that incorporates peer recovery support services must provide
10.7 written notice to the client that peer recovery support services will be provided.

10.8 (d) Peer recovery support services may include limited transportation or group activities
10.9 directly related to a client's individual recovery plan. Peer recovery support services may
10.10 not be provided to a client residing with or employed by a recovery peer from whom they
10.11 receive services.

10.12 Subd. 2. **Individual recovery plan.** (a) The individual recovery plan must be developed
10.13 with the client, and must be completed within the first three sessions with a recovery peer.
10.14 A recovery peer may bill for up to two hours prior to the client's completion of a
10.15 comprehensive assessment.

10.16 (b) The recovery peer must document how each session ties into the client's individual
10.17 recovery plan. The individual recovery plan must be updated as needed. The individual
10.18 recovery plan must include:

10.19 (1) the client's name;

10.20 (2) the recovery peer's name;

10.21 (3) the name of the recovery peer's supervisor;

10.22 (4) the client's recovery goals;

10.23 (5) the client's resources and assets to support recovery;

10.24 (6) activities that may support meeting identified goals; and

10.25 (7) the planned frequency of peer recovery support services sessions between the recovery
10.26 peer and the client.

10.27 Subd. 3. **Eligible vendor documentation requirements.** An eligible vendor of peer
10.28 recovery support services under section 254B.05, subdivision 1 must keep a secure file for
10.29 each individual receiving medical assistance peer recovery support services. The file must
10.30 include, at a minimum:

10.31 (1) the client's comprehensive assessment under section 245G.05 that led to the client's
10.32 referral for peer recovery support services;

- 11.1 (2) the client's individual recovery plan; and
- 11.2 (3) documentation of each billed peer recovery support services interaction between the
- 11.3 client and the recovery peer, including date, start and end time with a.m. and p.m.
- 11.4 designations, the client's response, and the name of the recovery peer who provided the
- 11.5 service.

11.6 **EFFECTIVE DATE.** This section is effective January 1, 2025.

11.7 **Sec. 9. RECOVERY PEERS; TIERED REIMBURSEMENT RATES.**

11.8 (a) The commissioner of human services shall develop and implement a tiered

11.9 reimbursement rate structure for recovery peers who meet the qualifications under Minnesota

11.10 Statutes, section 245I.04, subdivision 18. The rate structure must include two rate tiers, as

11.11 follows:

- 11.12 (1) tier one, providing peer recovery support services on a one-on-one basis; and
- 11.13 (2) tier two, providing peer recovery support services for a group of up to four clients,
- 11.14 if appropriate based on each client's individual recovery plan.

11.15 (b) The commissioner shall implement the tiered reimbursement rate structure no later

11.16 than September 1, 2024.

11.17 **Sec. 10. PEER RECOVERY SUPPORT SERVICES AND RECOVERY**

11.18 **COMMUNITY ORGANIZATION WORKING GROUP.**

11.19 Subdivision 1. **Establishment; duties.** The commissioner of human services must

11.20 convene a working group to develop recommendations on:

- 11.21 (1) peer recovery support services billing rates and practices, including a billing model
- 11.22 for providing services to groups larger than four clients at one time;
- 11.23 (2) acceptable activities to bill for peer recovery services, including group activities and
- 11.24 transportation related to individual recovery plans;
- 11.25 (3) ways to address authorization for additional service hours and a review of the amount
- 11.26 of peer recovery support services clients may need;
- 11.27 (4) improving recovery peer supervision and reimbursement for the costs of providing
- 11.28 recovery peer supervision for provider organizations;
- 11.29 (5) certification or other regulation of recovery community organizations and recovery
- 11.30 peers; and

12.1 (6) policy and statutory changes to improve access to peer recovery support services
12.2 and increase oversight of provider organizations.

12.3 Subd. 2. **Membership; meetings.** (a) Members of the working group must include, but
12.4 not be limited to:

12.5 (1) a representative of the Alliance for Recovery Centered Organizations;

12.6 (2) a representative of the Minnesota Alliance of Recovery Community Organizations;

12.7 (3) a representative of the Council on Accreditation of Peer Recovery Support Services;

12.8 (4) a representative of the Minnesota Association of Resources for Recovery and
12.9 Chemical Health;

12.10 (5) representatives from at least three recovery community organizations who are eligible
12.11 vendors of peer recovery support services under Minnesota Statutes, section 254B.05,
12.12 subdivision 1;

12.13 (6) at least two currently practicing recovery peers qualified under Minnesota Statutes,
12.14 section 245I.04, subdivision 18;

12.15 (7) at least two individuals currently providing supervision for recovery peers according
12.16 to Minnesota Statutes, section 245I.04, subdivision 19;

12.17 (8) the commissioner of human services or a designee;

12.18 (9) a representative of county social services agencies; and

12.19 (10) a representative of a Tribal social services agency.

12.20 (b) The commissioner of human services must make appointments to the working group
12.21 by July 1, 2024, and convene the first meeting of the working group by August 1, 2024.

12.22 (c) The commissioner of human services must provide administrative support and meeting
12.23 space for the working group. The working group may conduct meetings remotely.

12.24 Subd. 3. **Report.** The commissioner must complete and submit a report on the
12.25 recommendations in this section to the chairs and ranking minority members of the legislative
12.26 committees with jurisdiction over health and human services policy and finance on or before
12.27 December 15, 2024.
