## **Bill Description**

The bill, in part, creates a Task Force on Guardianship which consists of 16 members (two representatives, two senators, one judge, nine public members, two state agency members). Appointments must be made by June 30, 2024, and the first meeting of the task force must be held by September 1, 2024. The group must meet at least quarterly. Members may receive compensation and reimbursement for expenses as governed by MS 15.059, Subd 3. The task force must submit a report by December 31, 2025, at which the task force expires.

The Legislative Coordinating Commission (LCC) must provide administrative support, research support, and meeting location to the task force.

#### **Assumptions**

- 1. The task force will meet four times in FY25 with three meetings occurring during legislative session interim and then three times in FY26 with all meetings occurring during legislative session interim.
- 2. For this fiscal note we assume that all meetings will be held within the Capitol campus with limited remote participation and that costs may be absorbed. If this was to change with meetings held at locations that are outside the of the Capitol campus, additional resources may be needed.
- 3. Members may be eligible for per diem and expenses as provided by MS 15.059, Sub 3 (b).
- 4. The nine public members of the task force will be provided with per diem and reimbursement of expenses for their meeting participation. New funds would be needed for the LCC.
- 5. We assume that the one judge member and the two state agency members will not be eligible for per diem under MS 15.059 sub 3 (b). For this note we assume the judge member will seek reimbursement for expenses from the LCC instead of expenses being paid by the court of administration and new funds would be needed for the LCC. We assume that the two state agency members will be reimbursed for expenses from their employer.
- 6. The nine public member and one judge task force member meeting participation costs include the following per member per meeting expense costs: per diem (\$55/day, only for public members), \$102 round trip mileage (152 round trip mile average), meals (\$42/day) and lodging for half of the eligible members (\$150/night). The LCC would process the expense reimbursement request for the eligible members.
- 7. The bill does not provide for payment of per diems or for the reimbursement of expenses of legislators serving on the task force. However, legislative members could request reimbursement for expenses of engaging in legislative

- activity. This fiscal note is based on the assumption that the legislative members will be paid per diems and reimbursement for their expenses from the House and Senate. New funds will be needed for the House and Senate.
- 8. Legislative member meeting participation costs includes the following per member, per legislative interim meeting: per diem (\$86 senators, \$86 representatives), and \$102 round trip mileage (152 round trip mile average). Half of the legislative members will be reimbursed for lodging expenses (\$150/night senators, \$175/night representatives).
- 9. This note does not include any additional cost that non-legislative agencies may incur for interaction with staff and/or participation in meetings as requested by the task force.
- 10. Senate Counsel, Research and Fiscal Analysis will provide support of a composite of staff time of .02 FTE in FY25 (approximately 42 hours) and .01 FTE in FY26 (approximately 21 hours). For this fiscal note we assume existing Senate staff will be utilized and costs may be absorbed, although that will depend on the priorities of the legislature and staff time required for competing projects.
- 11. House Research Department and House Fiscal Analysis Department will provide support of a composite of staff time of .02 FTE in FY25 (approximately 42 hours) and .01 FTE in FY26 (approximately 21 hours). For this fiscal note we assume existing House staff will be utilized and costs may be absorbed, although that will depend on the priorities of the legislature and staff time required for competing projects.
- 12. The LCC will provide administrative staff support which is limited to logistical and planning support in addition to fiscal services which include the processing of task force member compensation and expense reimbursements. This support is anticipated to be .03 FTE in FY25 (approximately 63 hours) and .02 FTE in FY26 (approximately 42 hours). The LCC executive director will provide supervision and management support to the administrator for logistical and planning assistance at the request of the task force chair and vice chair. This is anticipated to be .02 FTE in FY25 (approximately 42 hours) and .01 FTE in FY26 (approximately 21 hours). The LCC will provide analyst support for research for the task force of .05 FTE in FY25 (approximately 104 hours) and .04 FTE in FY26 (approximately 84 hours). For this fiscal note we assume existing LCC staff will be utilized, and cost may be absorbed, although that will depend on the priorities of the legislature and staff time required for competing projects. If too many competing projects are required of the LCC, then additional funds will be needed than is what advised in this fiscal note.

## **Bill Description**

HF3483 amends Minn. Stat. § 524.5-313 (Powers and Duties of Guardian) at paragraph (c)(2) (duty to provide for care, comfort, and maintenance) to eliminate the statement that "the guardian shall have no personal or monetary liability" for failing to satisfy the needs and requirements of that clause; and amends Minn. Stat. § 524.5-315 (Rights and Immunities of Guardian; Limitations) to add a new paragraph (e) stating that failure to satisfy any of the duties under Minn. Stat. § 524.5-313(c) is grounds for removal but that a guardian shall not be personally liable for acts or omissions in the discharge of duties except for acts or omissions: 1) performed in a wanton, reckless, or intentional manner; 2) that constitute a known violation of law; or 3) that breach a fiduciary duty recognized elsewhere in law.

The bill also establishes a task force on guardianship that includes one judge appointed by the chief justice.

## **Assumptions**

It is assumed that this bill will not have a measurable impact on case filings or the judicial branch resources required to process cases filed against guardians.

This bill is not anticipated to have a significant fiscal impact on the judicial branch.
