1.5 **ELEMENTS.**

1.6 (a) No court, corrections officer, probation officer, or other placing authority, or an  
1.7 organization providing services under contract with any such individual or entity, shall  
1.8 directly or indirectly compel an individual to participate in any religious element of a  
1.9 substance use disorder treatment program if the individual objects in good faith. If an  
1.10 individual objects to the religious character or any religious element of a substance use  
1.11 disorder treatment program, the entity requiring the individual to receive substance use  
1.12 disorder treatment must document the individual's objection and may require the individual  
1.13 to participate in an equivalent alternative treatment program to which the individual has no  
1.14 religious objection. If an equivalent alternative treatment program is not available within a  
1.15 reasonable time, the individual may decline to participate in any religious element of a  
1.16 treatment program to which the individual objects. An individual's good faith refusal to  
1.17 participate in a treatment program or element of a treatment program for religious reasons  
1.18 may not adversely impact the individual's ability to receive treatment, the duration of the  
1.19 individual's treatment, or requirements for discharge from treatment.

1.20 (b) For purposes of this section, "directly or indirectly compel" means:

1.21 (1) requiring an individual to receive substance use disorder treatment from a specific  
1.22 type of program or treatment that includes religious elements;

1.23 (2) requiring an individual to receive substance use disorder treatment that meets  
1.24 nonclinical criteria that limits the number of equivalent alternative providers available, such

2.1 as requiring the individual to have a sponsor or prohibiting the individual from receiving  
2.2 medication-assisted treatment; or

2.3 (3) preventing an individual from receiving substance use disorder treatment solely  
2.4 because of the individual's objection to or refusal to participate in a religious element of the  
2.5 treatment program."

2.6 Page 3, lines 3 and 21, delete "254B.035" and insert "241.417"

2.7 Page 8, delete subdivision 1

2.8 Renumber the subdivisions in sequence

2.9 Page 9, line 30, delete "this" and insert "section 241.417."

2.10 Page 9, delete line 31

2.11 Page 10, delete section 12

2.12 Page 13, line 10, delete "254B.035" and insert "241.417"

2.13 Page 13, line 17, delete "section 254B.035" and insert "sections 241.417 and 254B.035"
