Bill Description

This legislation would define a plug-in solar photovoltaic device and exempt such devices from:

- (1) a requirement to enter an interconnection agreement with an electric utility;
- (2) the net metering provisions of section 216B.164; and
- (3) any fee, regulation, or required approval or reporting in regard to its installation or operation imposed by an electric utility.

Assumptions

Plug in solar systems are not generally in use in Minnesota, and commission staff do not process applications related to small DER systems such as this. It is not anticipated this would result in a change in PUC staff workload. In addition, since systems are not already subject to Commission fees and regulation, exempting these systems from "any fee, regulation, or required approval or reporting in regard to its installation or operation imposed by an electric utility" should not cause a fiscal impact on the Commission.

Bill Description

HF9096-0 regulates the installation and operation of plug-in solar photovoltaic devices.

Section 1:

- Subd. 1 establishes definitions for: “energy storage system”, “photovoltaic device”, and “plug-in solar photovoltaic device”.
- Subd. 2, paragraph (a) outlines three exemptions for plug-in solar photovoltaic devices. Paragraph (b) provides that an electric utility is not liable for damages or injuries caused by a plug-in solar photovoltaic device.

Section 1 is effective the day following final enactment.

The Minnesota Department of Commerce assumes the language of this bill has no fiscal impact for the agency.
