- Entire Offer Contingent on House Acceptance of Replacement of Senate Art. 2 § 122 (vehicle emissions standards authority repeal) with a two-year moratorium on adopting vehicle emissions standards (i.e., agency would be prohibited from adopting vehicle emissions standards prior to January 1, 2024).
- Accept the Following House Sections:
 - Art. 4 § 25 (PCA Must Use Current EPA Guidance in Prioritizing Superfund Projects) & related repeal of Minnesota Rules, part 7044.0350
 - Art. 4 § 26 (Priority Qualified Facilities Legislative Findings)

 - Art. 4 § 28 (Priority Qualified Facilities Calculation of Eminent Domain Damages)
