It is with pleasure that I write this letter of support for PICA Head Start. I have worked, volunteered, consulted, and supported PICA Head Start for over 19 years. I strongly endorse the remodeling and expansion of the Workforce Development Training Center and Lab School. The training center works with the community and PICA staff and parents to promote learning, inclusivity, equity, and diversity.

As a professor of Early Childhood Education and the Multiculturalism Program at the University of Wisconsin – Stout, I collaborate with PICA Head Start to place my students as volunteers in the program. Our university requires learning opportunities for students to gain knowledge and skills working with children and adults from diverse backgrounds and cultures. Last semester I had four students who volunteered for 30 hours so that they could gain more knowledge and teaching practice within a diverse school. As never before, Minnesota needs to invest in the training infrastructure that will produce a diverse and skilled early learning workforce. For 50 years, Parents in Community Action, Inc. has refined their successful early learning training systems targeting Minnesota's BIPOC communities and prepared hundreds of people to become infant/toddler specialists and preschool teachers. With targeted State investments, PICA can expand their training facilities to bring this quality workforce development opportunities to trainees across Minnesota.

As the former Executive Director for the Minnesota Head Start Association, I advocated for investments in training infrastructure to expand and diversify Minnesota's early childhood workforce. Parents in Community Action, Inc. services were often my model of a high-quality professional development system. Their services range from basic job readiness to apprentice training in EC classrooms, followed by certification and college degree opportunities. My name is Adriana Pasten Díaz and I am a Head Start teacher at Parents In Community Action in Minneapolis. I am here to tell you my story and how my family and I have benefited from PICA. I was born in Mexico and raised by my grandparents. My family at the time consisted of my husband, my daughter and a baby on the way when we moved to Minnesota in 2005. I got a job at a restaurant and one of my co-workers had told me about PICA. I came to PICA in 2008 to inquire about PICA and ended up signing my children up to attend PICA. When I met one of my children's teachers, she immediately told me about becoming a parent trainer not knowing this would be the beginning of my career at PICA.

I started my parent training in 2010 working in the infant and toddler room. While in the infant and toddler room, I learned so much about the development of young children. This experience not only helped me get a glimpse into PICA but it also gave me insight to the development of my own children being a young mom. After completing my 96 hours of parent training, I decided that this was something that I wanted to pursue so I applied to be a parent intern in PICA's intern program working with infants and toddlers. I worked full time in an Early Head Start classroom learning what it takes to be a teacher, how to do a lesson plan and interacting with the children. During this time, as part of the internship I was able to attend PICA's CDA program (Child Development Associate), a nationally credentialed early childhood certificate. This credential includes completing 120 hours of training, 450 hours of classroom experience, writing a portfolio and passing a test.

After completing my CDA and my internship I was hired to be a teacher at PICA. I began my career working in the full day program operating eight hours a day, five days a week, 12 months per year. I also worked in the preschool classroom and the collaborative program. The collaborative program is a program where Minneapolis and PICA staff work together in the classroom teaching children with special needs. I am very lucky to work in a very diverse program where the staff reflects the children and families both in culture and language. Having diverse teachers is very important to me for the children. I wanted my children to be with teachers who look and talk like them. My three children graduated from PICA and they still remember their

experiences and how happy they were knowing that I was working at PICA. They were always excited to go to school and to play with their classmates.

I would also like to point out that I graduated in 2019 from Minneapolis Community and Technical College through PICA, being the first in my family to attain a degree in college. My life has changed so much with being a part of PICA. I would have never thought I would be where I am but because of this career in PICA my family has benefited both financially and culturally. At PICA, we are not only giving a head start to children, but I was given a head start at becoming a teacher in this program where 48% of our staff of nearly 400 are currently or former Head Start parents and 90% are people of color. This level of diversity is very important and needed. As a teacher of color, I see the impact I have with my children in my classroom, being a role model for them. My children had that at PICA and I want that for other children as they continue their education which is why I support PICA Head Start so diverse people can have the same opportunity that I had and to take advantage of all the opportunities that the program offers to families. As a teacher of color and because of the opportunities I was given, I now have the credentials, full time job and security knowing that I have the skills, knowledge and desire to make this world better for children and families. My life story is living proof. Thank you.
