1.8 (a) The Metropolitan Council shall prepare and adopt, after appropriate study and such  
1.9 public hearings as may be necessary, a comprehensive development guide for the  
1.10 metropolitan area. It shall consist of a compilation of policy statements, goals, standards,  
1.11 programs, and maps prescribing guides for the orderly and economical development, public  
1.12 and private, of the metropolitan area. The comprehensive development guide shall recognize  
1.13 and encompass physical, social, or economic needs of the metropolitan area and those future  
1.14 developments which will have an impact on the entire area including but not limited to such  
1.15 matters as land use, climate action, parks and open space land needs, the necessity for and  
1.16 location of airports, highways, transit facilities, public hospitals, libraries, schools, and other  
1.17 public buildings.

1.18 (b) For the purposes of this section, "climate action" includes goals that meet or exceed  
1.19 the greenhouse gas emissions-reduction goals established by the state under section 216H.02,  
1.20 subdivision 1, and transportation targets established by the commissioner of transportation,  
1.21 including vehicle miles traveled reduction targets established in the statewide multimodal  
1.22 transportation plan under section 174.03, subdivision 1a.

2.5 "Sec. .... Minnesota Statutes 2022, section 473.859, subdivision 2, is amended to read:

2.6 Subd. 2. **Land use plan.** (a) A land use plan shall include the water management plan  
2.7 required by section 103B.235, and shall designate the existing and proposed location,  
2.8 intensity and extent of use of land and water, including lakes, wetlands, rivers, streams,  
2.9 natural drainage courses, and adjoining land areas that affect water natural resources, for  
2.10 agricultural, residential, commercial, industrial and other public and private purposes, or  
2.11 any combination of such purposes.

2.12 (b) A land use plan shall contain a protection element, as appropriate, for historic sites,  
2.13 the matters listed in the water management plan required by section 103B.235, and an  
2.14 element for protection and development of access to direct sunlight for solar energy systems.

2.15 (c) A land use plan shall also include a housing element containing standards, plans and  
2.16 programs for providing adequate housing opportunities to meet existing and projected local  
2.17 and regional housing needs, including but not limited to the use of official controls and land  
2.18 use planning to promote the availability of land for the development of low and moderate  
2.19 income housing.

2.20 (d) A land use plan shall also include the local government's goals, intentions, and  
2.21 priorities concerning aggregate and other natural resources, transportation infrastructure,  
2.22 land use compatibility, habitat, agricultural preservation, and other planning priorities,  
2.23 considering information regarding supply from the Minnesota Geological Survey Information  
2.24 Circular No. 46.

2.25 (e) A land use plan shall also include forecasts pertaining to greenhouse gas emissions  
2.26 and vehicle miles traveled that are generated from activity that occurs within the local  
2.27 government's jurisdiction, including from transportation, land use, energy use, solid waste,  
2.28 livestock, and agriculture, and the estimated impact of strategies that reduce or naturally  
2.29 sequester greenhouse gas emissions across sectors. The forecasts under this paragraph must  
2.30 analyze both efficient land use and compact growth scenarios.

2.31 **EFFECTIVE DATE; APPLICATION.** This section is effective the day following  
2.32 final enactment and applies in the counties of Anoka, Carver, Dakota, Hennepin, Ramsey,  
2.33 Scott, and Washington.
