1.3 "Section 1. Minnesota Statutes 2024, section 326B.107, subdivision 2, is amended to read:

1.4 Subd. 2. **Municipal agreement for all building projects.** (a) The commissioner shall

1.5 enter into an agreement with a municipality other than the state for plan review, inspection,

1.6 code administration, and code enforcement on public buildings and state-licensed facilities

1.7 in the jurisdiction if the municipality requests to provide those services and the commissioner

1.8 determines that the municipality has enough adequately trained and qualified ~~inspectors~~

1.9 persons to provide those services. In determining whether a municipality has enough

1.10 adequately trained and qualified ~~inspectors~~ persons to provide the service, the commissioner

1.11 must consider all ~~inspectors~~ code enforcement staff who are employed by the municipality,

1.12 are under contract with the municipality to provide ~~inspection~~ code enforcement services,

1.13 or are obligated to provide ~~inspection~~ code enforcement services to the municipality under

1.14 any other lawful agreement.

1.15 (b) The criteria used to make this determination shall be provided in writing to the

2.9 (2) adopt bylaws that specify the duties of its officers, the meeting dates of the board,
2.10 and containing other provisions as may be useful and necessary for the efficient conduct of
2.11 the business of the board;

2.12 (3) adopt the Minnesota Electrical Code, which must be the most current edition of the
2.13 National Electrical Code and any amendments thereto. The board shall adopt the most
2.14 current edition of the National Electrical Code and any amendments thereto pursuant to

3.23 apparatus and equipment on center pivot irrigation booms on the load side of the main
3.24 service on farmsteads, and install such other electrical equipment as is approved by the
3.25 commissioner. As of December 1, 2027, no new Class B installer licenses shall be issued.
3.26 An individual who holds a Class B installer license as of December 1, 2027, may retain and
3.27 renew the license and exercise the privileges the license grants.

4.28 Subd. 5. **Inspection fee for dwelling.** (a) The inspection fee for a one-family dwelling
4.29 and each dwelling unit of a two-family dwelling is the following:

4.30 (1) the fee for each service or other source of power as provided in subdivision 3;

4.31 (2) \$165 for up to 30 feeders and circuits; and

5.1 (3) for each additional feeder or circuit, the fee as provided in subdivision 4.

5.2 This fee applies to each separate installation for new dwellings and where ~~15~~ 14 or more
5.3 feeders or circuits are installed or extended in connection with any addition, alteration, or
5.4 repair to existing dwellings. Where existing feeders and circuits are reconnected to
5.5 overcurrent devices installed as part of the replacement of an existing panelboard, the fee
5.6 for each reconnected feeder or circuit is \$2. The maximum number of separate inspections

5.13 the dwelling unit may be combined with the dwelling unit fees to determine the maximum
5.14 number of separate inspections in accordance with subdivision 2.

5.15 (b) The inspection fee for each dwelling unit of a multifamily dwelling with three or
5.16 more dwelling units is \$110 for a combination of up to 20 feeders and circuits and \$12 for
5.17 each additional feeder or circuit. This fee applies to each separate installation for each new
5.18 dwelling unit and where ten or more feeders or circuits are installed or extended in connection
5.19 with any addition, alteration, or repair to existing dwelling units. Where existing feeders or
5.20 circuits are reconnected to overcurrent devices installed as part of the replacement of an
5.21 existing panelboard, the fee for each reconnected feeder or circuit is \$2. The maximum
5.22 number of separate inspections for each dwelling unit shall be determined in accordance
5.23 with subdivision 2. The fee for additional inspections or for inspection of other installations
5.24 is that specified in subdivisions 2, 4, 6, and 8. These fees include only inspection of the
5.25 wiring within individual dwelling units and the final feeder to that unit where the multifamily
5.26 dwelling is provided with common service equipment and each dwelling unit is supplied
5.27 by a separate feeder or feeders extended from common service or distribution equipment.
5.28 The fee for multifamily dwelling services or other power source supplies and all other
5.29 circuits is that specified in subdivisions 2 to 4.

5.30 (c) A separate request for electrical inspection form must be filed for each dwelling unit
5.31 that is supplied with an individual set of service entrance conductors. These fees are the
5.32 one-family dwelling rate specified in paragraph (a).

6.1 Sec. 7. Minnesota Statutes 2025 Supplement, section 326B.37, subdivision 6, is amended
6.2 to read:

6.3 Subd. 6. **Additions to fees of subdivisions 3 to 5.** (a) The fee for the electrical supply
6.4 for each manufactured home park lot is \$35. This fee includes the service or feeder conductors
6.5 up to and including the service equipment or disconnecting means. The fee for feeders and
6.6 circuits that extend from the service or disconnecting means is that specified in subdivision
6.7 4.

6.8 (b) The fee for each recreational vehicle site electrical supply equipment is \$12 for each
6.9 circuit originating within the equipment. The fee for recreational vehicle park services,
6.10 feeders, and circuits is that specified in subdivisions 3 and 4.

6.11 (c) The fee for each street, parking lot, or outdoor area lighting standard and each traffic
6.12 signal standard is \$5. Circuits originating within the standard or traffic signal controller

6.16 The previous sentence does not apply to Class 1 transformers or power supplies for Class
6.17 1 power-limited circuits or to Class 2 or Class 3 transformers or power supplies.

6.18 (e) The fee for transformers and electronic power supplies for electric signs and outline
6.19 lighting is \$5 per unit.

6.20 (f) The fee for technology circuits or systems, and circuits of less than 50 volts, is 75
6.21 cents for each system device or apparatus.

6.22 (g) The fee for each separate inspection of the bonding for a swimming pool, spa,
6.23 fountain, an equipotential plane for an agricultural confinement area, or similar installation
6.24 is ~~\$35~~ \$55. Bonding conductors and connections require an inspection before being
6.25 concealed.

6.26 (h) The fee for all wiring installed on center pivot irrigation booms is \$35 plus \$5 for
6.27 each electrical drive unit.

6.28 (i) The fee for retrofit modifications to existing lighting fixtures is 25 cents per luminaire.

6.29 (j) When a separate inspection of a concrete-encased grounding electrode is performed,
6.30 the fee is \$55.

6.31 (k) The fees required by subdivisions 3 and 4 are doubled for installations over 600
6.32 volts.

7.1 (l) The fee for a class 4 circuit or system transmitter, receiver, or utilization equipment
7.2 is \$0.50 for each system device or apparatus.

7.3 Sec. 8. Minnesota Statutes 2024, section 326B.37, subdivision 7, is amended to read:

7.4 Subd. 7. **Investigation fee: work without electrical inspection request.** (a) Whenever
7.5 any work for which a request for electrical inspection is required has begun without the
7.6 request for electrical inspection form being filed with the commissioner, a special
7.7 investigation shall be made before a request for electrical inspection form is accepted.

7.8 (b) An investigation fee, in addition to the full fee required by subdivisions 1 to 6 and
7.9 16 to 18, shall be paid before an inspection is made. The investigation fee is two times the
7.10 minimum fee specified in subdivision 2 or the applicable inspection fee required by
7.11 subdivisions 1 to 6 and 16 to 18, whichever is greater, not to exceed \$1,000. The payment
7.12 of the investigation fee does not exempt any person from compliance with all other provisions
7.13 of the department rules or statutes nor from any penalty prescribed by law.
