1.6 Section 1. [297A.651] LOTTERY GAMING MACHINES; IN-LIEU TAX.

1.7 Adjusted gross revenue from the operation of gaming machines authorized under
1.8 chapter 349A is exempt from the tax imposed under section 297A.62. The State Lottery
1.9 must, on or before the 20th day of each month, transmit to the commissioner an amount
1.10 equal to the adjusted gross revenue from the operation of gaming machines, as defined
1.11 in section 349A.01, for the previous month multiplied by: (1) 25 percent of annual
1.12 adjusted gross revenue generated by the licensee up to \$125,000,000; (2) 30 percent
1.13 of annual adjusted gross revenue generated by the licensee between \$125,000,000 and
1.14 \$200,000,000; and (3) 40 percent of annual adjusted gross revenue generated by the
1.15 licensee in excess of \$200,000,000. The commissioner shall deposit the money transmitted
1.16 under this section in the state treasury in the multi-stadium revenue fund in section 17.

1.21 more than one gambling device in any calendar year;

2.24 Subd. 5. **Gambling prohibited.** (a) Except as otherwise provided in this
2.25 subdivision, no retail establishment licensed to sell alcoholic beverages may keep, possess,
2.26 or operate, or permit the keeping, possession, or operation on the licensed premises of dice
2.27 or any gambling device as defined in section 349.30, or permit gambling therein.

2.28 (b) Gambling equipment may be kept or operated and raffles conducted on licensed
2.29 premises and adjoining rooms when the use of the gambling equipment is authorized by
2.30 (1) chapter 349, (2) a tribal ordinance in conformity with the Indian Gaming Regulatory

4.1 Subd. 3. **Lottery operations.** (a) The director shall establish a lottery operations
4.2 account in the lottery fund. The director shall pay all costs of operating the lottery,
4.3 including payroll costs or amounts transferred to the state treasury for payroll costs, but
4.4 not including lottery prizes, from the lottery operating account. The director shall credit to
4.5 the lottery operations account amounts sufficient to pay the operating costs of the lottery.

4.6 (b) Except as provided in paragraph (e), the director may not credit in any fiscal
4.7 year thereafter amounts to the lottery operations account which when totaled exceed
4.8 nine percent of gross revenue to the lottery fund in that fiscal year. In computing total
4.9 amounts credited to the lottery operations account under this paragraph the director shall

4.20 the lottery and to credit up to 25 percent of an amount equal to the average annual amount

4.26 (1) authorizes the director to conduct a lottery game or contest the winner or winners

4.28 under chapter 240;

4.29 (2) authorizes the director to install or operate a lottery device operated by coin or
4.30 currency which when operated determines the winner of a game, except as authorized

5.1 Subdivision 1. **Location contract.** (a) The director may enter into a contract with
5.2 a person to provide locations for gaming machines. Contracts entered into under this
5.3 section are not subject to chapter 16C. The director may only enter a contract under this
5.4 subdivision with a person who holds a class A license under chapter 240 for a racetrack
5.5 offering thoroughbred and quarterhorse racing. The gaming machines may only be placed
5.6 at the racetrack for which the class A license under chapter 240 was issued. Contracts
5.7 entered into under this section are void if the racetrack: (1) has not hosted at least 75 days
5.8 of live racing, authorized by the Minnesota Racing Commission, during the previous year,
5.9 or (2) has not been approved, unless approval is pending, for at least 75 days of live racing
5.10 during the present year.

5.11 (b) Contracts entered into must provide for compensation to the racetrack in an
5.12 amount equal to at least the following percentages of adjusted gross gaming machine
5.13 revenue generated at the track: (1) 60 percent of the first \$125,000,000 of annual revenue;
5.14 (2) 55 percent of annual revenue between \$125,000,000 and \$200,000,000; and (3) 45
5.15 percent of annual revenue in excess of \$200,000,000.

5.16 (c) From the compensation received by the racetrack under this section, the racetrack
5.17 shall annually remit an amount equal to one percent of the adjusted gross gaming machine
5.18 revenue to both the city and the county where the racetrack is located.

5.19 Subd. 2. **Operation.** (a) All gaming machines that are placed at a racetrack under
5.20 subdivision 1 must be operated and controlled by the director.

5.21 (b) Gaming machines must be owned or leased by the director, however, the financial
5.22 responsibility for all other activities related to the gaming facility including, but not
5.23 limited to, advertising, marketing, facility expenses, staffing, security, and surveillance,
5.24 shall be borne by the holder of the location contract.

5.25 (c) Gaming machines must be maintained by the lottery, or by a vendor that is under
5.26 the control and direction of the director.

5.27 (d) The director must have a central communications system that monitors activities
5.28 on each gaming machine. The central communications system must be located at a
5.29 lottery office.

5.30 (e) The director must supervise the general security arrangements associated
5.31 with and relating to the operation of the gaming machines and implement procedures
5.32 as deemed appropriate.

5.33 (f) Advertising and promotional material produced by the racetrack relating to
5.34 gaming machines located at the facility must be approved by the director.

5.35 (g) The director may implement such other controls as are deemed necessary for the
5.36 operation of gaming machines under this section.

6.1 Subd. 3. **Specifications.** Gaming machines must:

6.2 (1) maintain on nonresettable meters a permanent record, capable of being printed
6.3 out, of all transactions by the machine and all entries into the machine; and

6.4 (2) be capable of being linked electronically to a central communications system to
6.5 provide auditing program information as required by the director.

6.6 Subd. 4. **Games.** The director shall specify the games that may be placed on
6.7 a gaming machine as provided in section 349A.04. Gaming machines may conduct
6.8 pari-mutuel wagering and display horse races under specifications provided by the director.

6.9 Subd. 5. **Examination of machines.** The director shall examine prototypes of
6.10 gaming machines and require that the manufacturer of the machine pay the cost of the
6.11 examination. The director may contract for the examination of gaming machines.

6.12 Subd. 6. **Testing of machines.** The director may require working models of a
6.13 gaming machine to be transported to the locations the director designates for testing,
6.14 examination, and analysis. The manufacturer shall pay all costs for testing, examination,
6.15 analysis, and transportation of the machine model.

6.16 Subd. 7. **Prizes.** A person who plays a gaming machine agrees to be bound by the
6.17 rules and game procedures applicable to that particular gaming machine game. The player
6.18 acknowledges that the determination of whether the player has won a prize is subject to
6.19 the rules and game procedures adopted by the director, claim procedures established by
6.20 the director for the game, and any confidential or public validation tests established by
6.21 the director for the game. A person under 18 years of age may not claim a prize from the
6.22 operation of a gaming machine. A prize claimed from the play of a gaming machine game
6.23 is not subject to section 349A.08, subdivision 8.

6.24 Subd. 8. **Prohibitions.** (a) A person under the age of 18 years may not play a
6.25 game on a gaming machine.

6.26 (b) The director or any employee of the lottery, or a member of the immediate family
6.27 residing in the same household, may not play a game on a gaming machine or receive a
6.28 prize from the operation of a gaming machine.

6.29 Subd. 9. **Compulsive gambling notice.** The director shall prominently post, in the
6.30 area where the gaming machines are located, the toll-free telephone number established
6.31 by the commissioner of human services in connection with the compulsive gambling
6.32 program established under section 245.98. The director and the location provider shall
6.33 establish a responsible gambling plan in consultation with the National Council on
6.34 Problem Gambling or the Minnesota affiliate. By January 15 of each year, the director
6.35 shall submit a report to the legislature, of not more than five pages in length, setting forth
6.36 the status of the responsible gambling plan.

7.1 Subd. 10. **Local licenses.** Except as provided in subdivision 1, no political
7.2 subdivision may require a license to operate a gaming machine, restrict or regulate the
7.3 placement of gaming machines, or impose a tax or fee on the business of operating
7.4 gaming machines.

7.6 **541.20 RECOVERY OF MONEY LOST.**

7.7 Every person who, by playing at cards, dice, or other game, or by betting on the
7.8 hands or sides of such as are gambling, shall lose to any person so playing or betting
7.9 any sum of money or any goods, and pays or delivers the same, or any part thereof, to
7.10 the winner, may sue for and recover such money by a civil action, before any court
7.11 of competent jurisdiction. For purposes of this section, gambling shall not include
7.12 pari-mutuel wagering conducted under a license issued pursuant to chapter 240, purchase
7.13 or sale of tickets in the state lottery, purchase of gaming machine plays as authorized under
7.14 chapter 349A, or gambling authorized under chapters 349 and 349A.

7.17 Every note, bill, bond, mortgage, or other security or conveyance in which the whole
7.18 or any part of the consideration shall be for any money or goods won by gambling or
7.19 playing at cards, dice, or any other game whatever, or by betting on the sides or hands
7.20 of any person gambling, or for reimbursing or repaying any money knowingly lent or
7.21 advanced at the time and place of such gambling or betting, or lent and advanced for any
7.22 gambling or betting to any persons so gambling or betting, shall be void and of no effect
7.23 as between the parties to the same, and as to all persons except such as hold or claim
7.24 under them in good faith, without notice of the illegality of the consideration of such
7.25 contract or conveyance. The provisions of this section shall not apply to: (1) pari-mutuel
7.26 wagering conducted under a license issued pursuant to chapter 240; (2) purchase of tickets
7.27 in the state lottery or other wagering authorized under chapter 349A; (3) gaming activities

8.1 (2) a contract for the purchase or sale at a future date of securities or other
8.2 commodities;

8.3 (3) offers of purses, prizes or premiums to the actual contestants in any bona fide
8.4 contest for the determination of skill, speed, strength, endurance, or quality or to the bona
8.5 fide owners of animals or other property entered in such a contest;

8.6 (4) the game of bingo when conducted in compliance with sections 349.11 to 349.23;

8.18 the state lottery or the sale, possession, or purchase of tickets for the state lottery under
8.19 chapter 349A, or the manufacture, possession, sale, or operation of a gaming machine
8.20 under chapter 349A.

8.21 Sec. 17. **MULTI-STADIUM REVENUE FUND.**

8.22 The multi-stadium revenue fund is established as a special account in the state
8.23 treasury. The fund consists of money deposited in the fund under Minnesota Statutes,
8.24 section 297A.651, and any interest earned thereon. Money in the fund may not be spent
8.25 unless appropriated by law and is dedicated for the financing and construction of a
8.26 professional football stadium for the Minnesota Vikings and a regional ballpark for the
8.27 St. Paul Saints. Money in the fund is intended to pay all necessary debt service on bonds
8.28 authorized by an act of the legislature, for capital costs relating to a professional football
8.29 stadium for the Minnesota Vikings and a regional ballpark for the St. Paul Saints. The
8.30 commissioner shall determine the debt service amount required by such act, as provided
8.31 in Minnesota Statutes, section 16A.643. Appropriations may be made on an annual or
8.32 biennial basis and may be made to the commissioner of management and budget for
8.33 transfer to the bond debt service account in the state bond fund.

9.2 If any provision of this act is found to be invalid because it is in conflict with a
9.3 provision of the Minnesota Constitution or the Constitution of the United States, or for any
9.4 other reason, all other provisions of this act shall remain valid and any rights, remedies,
9.5 and privileges that have been otherwise accrued by this act, shall remain in effect and may
9.6 be proceeded with and concluded under this act.
