

1.1 Senator moves to amend the unofficial engrossment (UEH2294-1) to
1.2 H.F. No. 2294, in conference committee, as follows:

1.3 On R75, Article 4, Senate language, (UEH2294-1)

1.4 Page 107, after line 13, insert:

1.5 "Sec. 41. **INSTRUCTIONS TO THE COMMISSIONERS TO DEVELOP A**
1.6 **PLAN FOR AN AUTISM RESIDENTIAL CAMPUS.**

1.7 (a) The commissioner of human services, in consultation with the commissioners
1.8 of education and employment and economic development, shall develop a plan to create
1.9 a residential campus providing 24-hour supervision for individuals with a diagnosis of
1.10 autistic disorder as defined by diagnostic code 299.0 in the Diagnostic and Statistical
1.11 Manual of Mental Disorders (DSM-IV). This plan must identify how the costs and
1.12 programming will be shared between the agencies so that the social, educational, sensory,
1.13 and vocational needs of the individuals served by the program will be met.

1.14 (b) The plan must be developed no later than August 31, 2012.

1.15 Sec. 42. **INSTRUCTIONS TO THE COMMISSIONER TO REQUEST A**
1.16 **WAIVER AND CREATE AND FUND AN AUTISM RESIDENTIAL CAMPUS.**

1.17 (a) The commissioner of human services shall develop a proposal to the United
1.18 States Department of Health and Human Services which shall include any necessary
1.19 waivers, state plan amendments, and any other federal authority that may be necessary to
1.20 create and fund the program in paragraph (b).

1.21 (b) The commissioner shall request authority to create and fund a residential campus
1.22 program to serve individuals to age 21 who are diagnosed with autistic disorder as defined
1.23 by diagnostic code 299.0 in the Diagnostic and Statistical Manual of Mental Disorders
1.24 (DSM-IV), and who are able to live in a supported housing environment that provides
1.25 24-hour supervision. The program must:

1.26 (1) provide continuous on-site supervision;

1.27 (2) provide sensory or other therapeutic programming as appropriate for each
1.28 resident; and

1.29 (3) incorporate independent living skills, socialization skills, and vocational skills,
1.30 as appropriate for each resident.

1.31 (c) The commissioner shall submit the proposal no later than January 1, 2013."
