Market-based approach to ECE

- Demand-side
 - Empower parents with tools: parent mentors, information and scholarships
- Supply-side
 - Must achieve 3- or 4-star Parent Aware rating
 - ECE programs compete for scholarship families

- Parent engagement
- More high-quality openings at ECE programs

Scholarship Program Eligibility

Residence: Live in Frogtown, North End or Payne-Phalen neighborhoods in St. Paul

Income: Below 185% of poverty

Child Age: Either age 3 or age 0-1 on September 1st of current school year

Pilot timeframe: January 2008 through August 2011

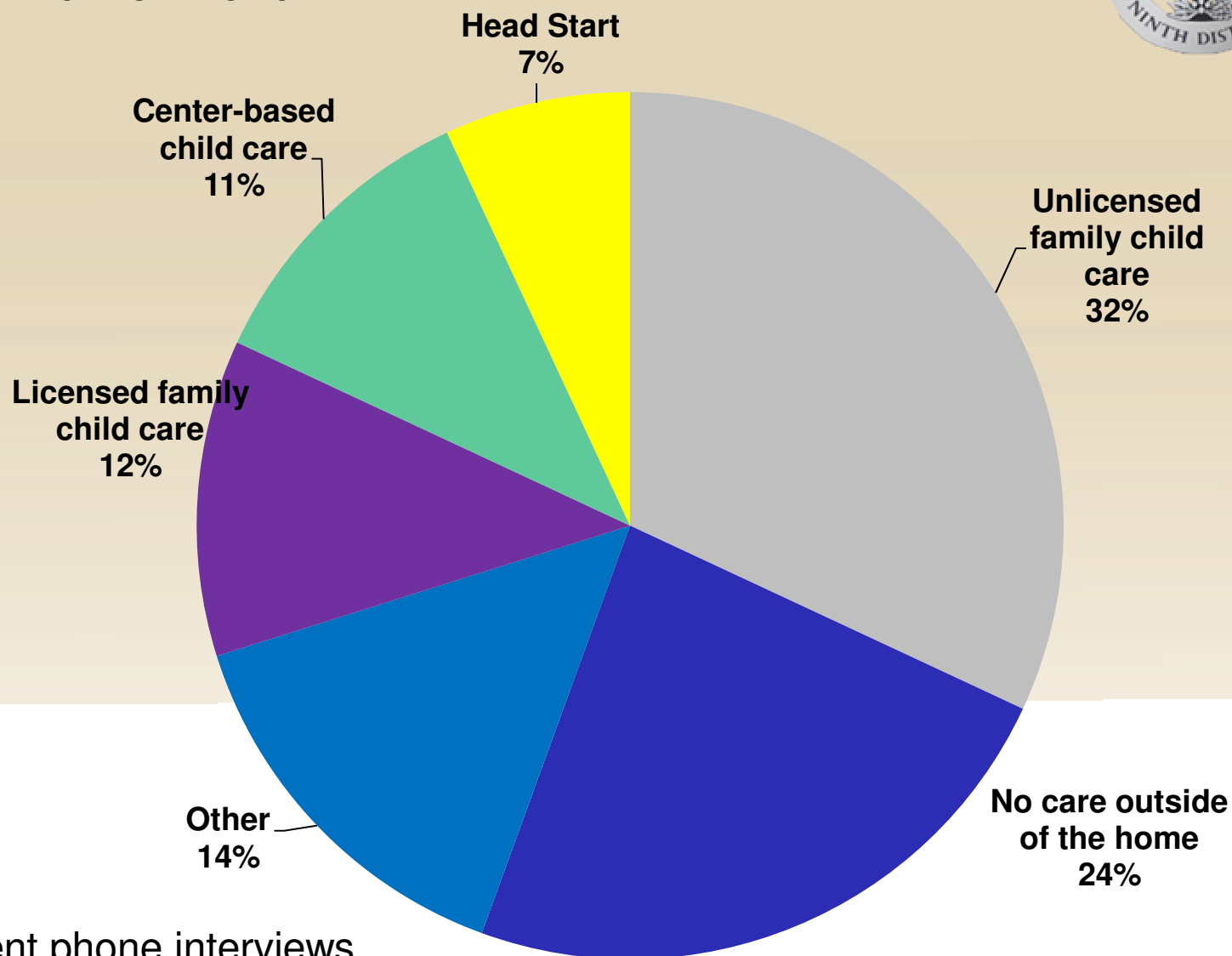

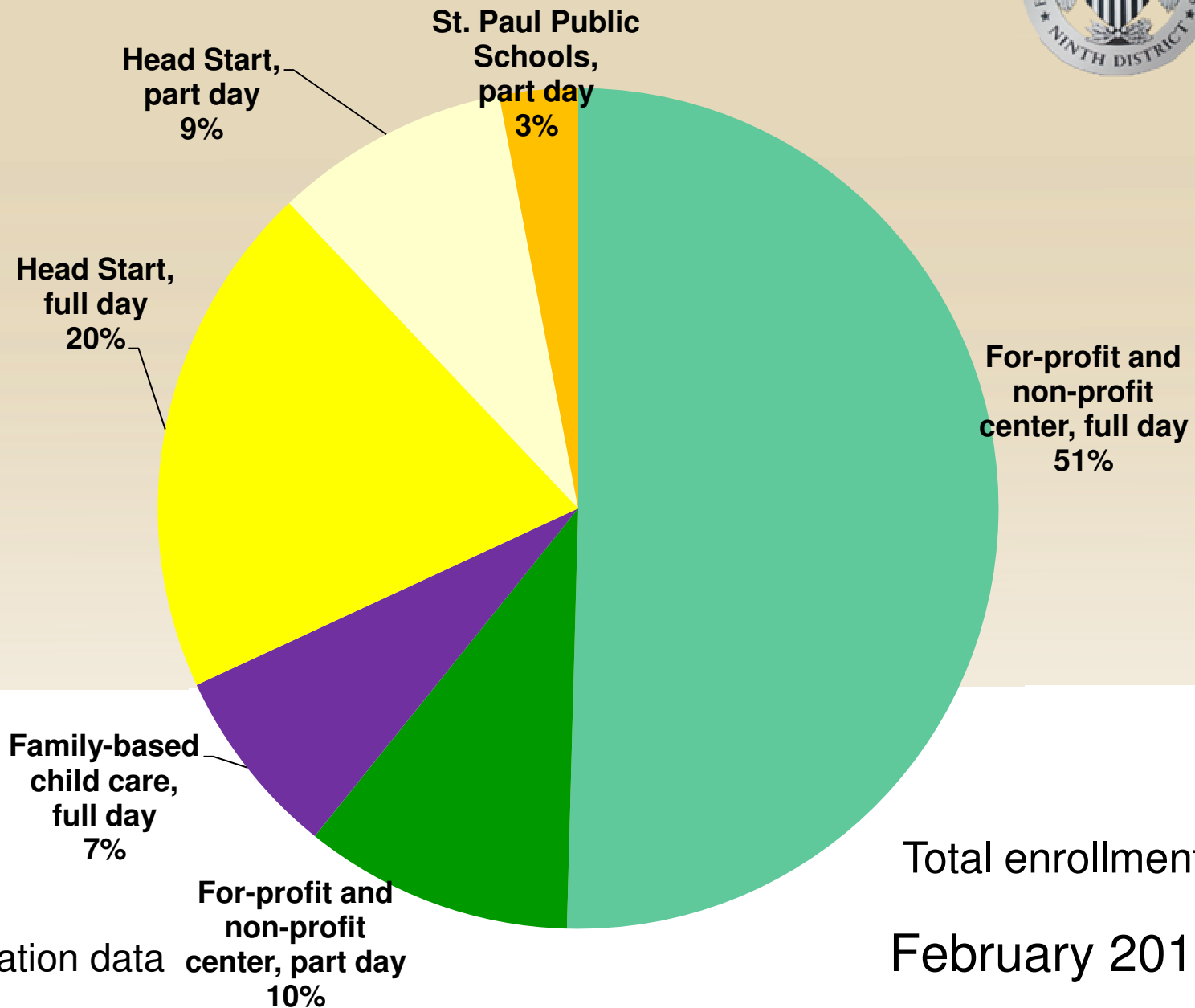
Parents' report of child's care prior to Scholarship Program enrollment

MELF Scholarship Evaluation Findings

Based on interviews by SRI

- Increased support for and awareness of high-quality ECE programs
- Overall, implementation went well
- Challenges:
 - Transportation
 - Recruitment: Person-to-person works best
 - Integrating non-tuition programs into model



Scholarship parent responses

- Enthusiastic about the program
- Program considered user friendly
- Participation provided school and work opportunities
- Strong positive opinions about parent mentors



Lessons in progress

- More children enrolled in high-quality programs
- More spaces at high-quality programs
- Parents involved in children's education
- Next year: Information on child outcomes
