Representative Coulter moved that the minutes from March 23rd, 2026, be adopted. THE MOTION PREVAILED.

HF 4348 (Kraft) Thermal energy networks designated as public improvements and waterworks.

Representative Freiberg brought HF 4348 before the committee.

Representative Freiberg moved that HF 4348 be placed on the General Register.

Representative Freiberg moved that the H4348A1 amendment to HF 4348 be adopted. THE MOTION PREVAILED. THE AMENDMENT WAS ADOPTED.

Representative Kraft presented HF 4348, as amended.

HF 4202 (Hanson, J.) Provisions relating to local unit of government's regulation of cannabis businesses modified.

Representative Freiberg moved that HF 4202 be re-referred to the Commerce Finance and Policy committee.

HF 4186 (Luger-Nikolai) Housing and redevelopment agencies authorized to utilize certain long-term equity investment authority, and investment types in which a qualifying government may invest modified.

HF 4455 (Lee) Ramsey County human resources personnel structure terminology updated, certain positions adjusted to unclassified service for consistency with other positions, obsolete language repealed, and technical changes made.

Representative Freiberg brought HF 4455 before the committee.

Representative Lee moved that HF 4455 be placed on the General Register.

Representative Lee moved the H4455A1 amendment to HF 4455. THE MOTION PREVAILED. THE AMENDMENT WAS ADOPTED.

Representative Lee renewed the motion that HF 4455, as amended, be placed on the General Register. THE MOTION PREVAILED.

HF 3883 (Freiberg) Water supply planning and reporting requirements clarified.

Representative Freiberg brought HF 3883 before the committee.

Representative Freiberg moved the H3883DE1 amendment to HF 3883.

Representative Freiberg moved the H3883A2 amendment to the H3883DE1 amendment. THE MOTION PREVAILED. THE AMENDMENT WAS ADOPTED.

Representative Freiberg renewed the motion that the H3883DE1 amendment, as amended, to HF 3883, be adopted. THE MOTION PREVAILED. THE AMENDMENT WAS ADOPTED.

Representative Freiberg moved that HF 3883, as amended, be placed on the General Register. THE MOTION PREVAILED.

HF 4242 (Freiberg) Provisions governing disposition of decedents' personal property by coroners and medical examiners modified.

Representative Freiberg brought HF 4242 before the committee.

Representative Freiberg moved that HF 4242 be placed on the General Register.

Representative Freiberg moved the H4242A1 amendment to HF 4242. THE MOTION PREVAILED. THE AMENDMENT WAS ADOPTED.

Representative Freiberg presented HF 4242, as amended.

Representative Freiberg renewed the motion that HF 4242, as amended, be placed on the General Register. THE MOTION PREVAILED.

HF 2688 (Greenman) A resolution memorializing Congress to overturn the United States Supreme Court decision Citizens United v. FEC, requesting that Congress clarify that the rights protected under the Constitution are the rights of natural persons and not the rights of artificial

entities and that spending money to influence elections is not speech under the First Amendment, and asking that Congress propose a constitutional amendment to provide such clarification.

Representative Greenman moved that HF 2688 be re-referred to the Rules and Legislative Administration committee.

Representative Greenman moved the A1 amendment to HF 2688. THE MOTION PREVAILED. THE AMENDMENT WAS ADOPTED.

Representative Greenman presented HF 2688, as amended.

Representative Gordon renewed the motion that HF 3295, as amended, be placed on the General Register. THE MOTION PREVAILED.

HF 3862 (Freiberg) Secretary of state required to prepare and distribute a voter information guide prior to each statewide general election, and rulemaking authorized.

Representative Freiberg brought HF 3862 before the committee.

Representative Freiberg moved the DE1 amendment to HF 3862. THE MOTION PREVAILED.
THE AMENDMENT WAS ADOPTED.

Representative Freiberg presented HF 3862, as amended.
