1.13	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.14	Section 1. Minnesota Statutes 2022, section 518B.01, subdivision 3a, is amended to read:
1.15	Subd. 3a. Filing fee. The filing fees for an order for protection under this section are
1.16	waived for the petitioner and respondent. The court administrator, the sheriff of any county
1.17	in this state, and other law enforcement and corrections officers shall perform their duties
1.18	relating to service of process without charge to the petitioner. The court shall direct payment
1.19	of the reasonable costs of service of process if served by a private process server when the
1.20	sheriff or other law enforcement or corrections officer is unavailable or if service is made
1.21	by publication, without requiring the petitioner to make application under section 563.01.

on the respondent electronically or by first class mail, as ordered by the court. Orders for
dismissal may be served personally or by certified mail. In lieu of personal service of an
order for protection, a law enforcement officer may serve a person with a short-form
notification as provided in subdivision 8a.

(b) When service is made out of this state and in the United States, it may be proved by 2.5 the affidavit of the person making the service. When service is made outside the United 2.6 States, it may be proved by the affidavit of the person making the service, taken before and 2.7 certified by any United States minister, charge d'affaires, commissioner, consul, or 2.8 commercial agent, or other consular or diplomatic officer of the United States appointed to 2.9 reside in the other country, including all deputies or other representatives of the officer 2.10 authorized to perform their duties; or before an office authorized to administer an oath with 2.11 the certificate of an officer of a court of record of the country in which the affidavit is taken 2.12 as to the identity and authority of the officer taking the affidavit. 2.13

(c) If personal service cannot be made, the court may order service of the petition and 2.14 any order issued under this section by alternate means, or by publication, which publication 2.15 must be made as in other actions. The application for alternate service must include the last 2.16 known location of the respondent; the petitioner's most recent contacts with the respondent; 2.17 the last known location of the respondent's employment; the names and locations of the 2.18 respondent's parents, siblings, children, and other close relatives; the names and locations 2.19 of other persons who are likely to know the respondent's whereabouts; and a description of 2.20 efforts to locate those persons. 2.21

2.22 The court shall consider the length of time the respondent's location has been unknown, 2.23 the likelihood that the respondent's location will become known, the nature of the relief 2.24 sought, and the nature of efforts made to locate the respondent. The court shall order service 2.25 by first class mail, forwarding address requested, to any addresses where there is a reasonable 2.26 possibility that mail or information will be forwarded or communicated to the respondent.

2.27 The court may also order publication, within or without the state, but only if it might
2.28 reasonably succeed in notifying the respondent of the proceeding. Service shall be deemed
2.29 complete 14 days after mailing or 14 days after court-ordered publication.

(d) A petition and any order issued under this section, including the short-form
notification, must include a notice to the respondent that if an order for protection is issued
to protect the petitioner or a child of the parties, upon request of the petitioner in any
parenting time proceeding, the court shall consider the order for protection in making a
decision regarding parenting time.

A restraining order may be issued only against the respondent named in the petition; except 5.6 that if the respondent is an organization, the order may be issued against and apply to all of 5.7 the members of the organization. If the court finds that the petitioner has had two or more 5.8 previous restraining orders in effect against the same respondent or the respondent has 5.9 5.10 violated a prior or existing restraining order on two or more occasions, relief granted by the restraining order may be for a period of up to 50 years. In all other cases, relief granted by 5.11 the restraining order must be for a fixed period of not more than two years. When a referee 5.12 presides at the hearing on the petition, the restraining order becomes effective upon the 5.13 referee's signature. 5.14

(c) An order issued under this subdivision must be personally served upon the respondent,
or if the respondent appears remotely for a hearing and is notified at the hearing by the
judicial officer that a restraining order will be issued, the order may be served on the
respondent electronically or by first class mail, as ordered by the court.

(d) If the court orders relief for a period of up to 50 years under paragraph (a), the 5.19 respondent named in the restraining order may request to have the restraining order vacated 5.20 or modified if the order has been in effect for at least five years and the respondent has not 5.21 violated the order. Application for relief under this paragraph must be made in the county 5.22 in which the restraining order was issued. Upon receipt of the request, the court shall set a 5.23 hearing date. Personal service must be made upon the petitioner named in the restraining 5.24 order not less than 30 days before the date of the hearing. At the hearing, the respondent 5.25 5.26 named in the restraining order has the burden of proving by a preponderance of the evidence that there has been a material change in circumstances and that the reasons upon which the 5.27 court relied in granting the restraining order no longer apply and are unlikely to occur. If 5.28 the court finds that the respondent named in the restraining order has met the burden of 5.29 proof, the court may vacate or modify the order. If the court finds that the respondent named 5.30 in the restraining order has not met the burden of proof, the court shall deny the request and 5.31 no request may be made to vacate or modify the restraining order until five years have 5.32 elapsed from the date of denial. 7.6	Subdivision 1. Establishment. The Task Force on Domestic Violence and Firearms is
7.7	established to review existing laws that require the surrender of firearms by individuals
7.8	subject to an order for protection, subject to an extreme risk protection order, or convicted
7.9	of domestic assault, harassment, or stalking; identify best practices to ensure the surrender
7.10	of firearms that prioritize the safety of peace officers, victims, and others; identify policies
7.11	and procedures that reduce the danger to peace officers and other emergency responders
7.12	called to an incident involving domestic violence; and make policy and funding
7.13	recommendations to the legislature.
7.14	Subd. 2. Membership. (a) The task force consists of the following members:
7.15	(1) the commissioner of public safety, or a designee;
7.16	(2) the director of the Missing and Murdered Indigenous Relatives Office, or a designee;
7.17	(3) the chief justice of the supreme court, or a designee;
7.18	(4) the state public defender, or a designee;
7.19	(5) a county attorney appointed by the Minnesota County Attorneys Association;
7.20	(6) an individual appointed by the Indian Affairs Council;
7.21	(7) a peace officer as defined in Minnesota Statutes, section 626.84, subdivision 1,
7.22	paragraph (c), appointed by the Minnesota Chiefs of Police Association;
7.23	(8) a peace officer as defined in Minnesota Statutes, section 626.84, subdivision 1,
7.24	paragraph (c), appointed by the Minnesota Sheriffs' Association;
7.25	(9) an individual appointed by Violence Free Minnesota;

7.28	of Minnesota Law School.
7.29	(b) Appointments must be made no later than September 1, 2024.
7.30	(c) Members shall serve without compensation.

8.1	(d) Members of the task force serve at the pleasure of the appointing authority or until
8.2	the task force expires. Vacancies shall be filled by the appointing authority consistent with
8.3	the qualifications of the vacating member required by this subdivision.
8.4	Subd. 3. Officers; meetings. (a) The commissioner of public safety shall convene the
8.5	first meeting of the task force no later than September 15, 2024, and shall provide meeting
8.6	space and administrative assistance for the task force to conduct its work.
8.7	(b) At its first meeting, the task force must elect a chair and vice-chair from among its
8.8	members. The task force may elect other officers as necessary.
8.9	(c) The task force shall meet at least monthly or upon the call of the chair. The task force
8.10	shall meet sufficiently enough to accomplish the tasks identified in this section. Meetings
8.11	of the task force are subject to Minnesota Statutes, chapter 13D.
8.12	Subd. 4. Duties. (a) The task force shall, at a minimum:
8.13	(1) review relevant information regarding the intersection between domestic violence
8.14	and firearm violence;
8.15	(2) examine existing laws requiring the surrender of firearms by individuals subject to
8.16	orders for protection, convicted of domestic assault, and convicted of harassment or stalking;
8.17	(3) examine existing policies and procedures, if any, used in Minnesota to enforce orders
8.18	requiring the surrender of firearms by individuals subject to an order for protection or
8.19	convicted of domestic assault, harassment, or stalking;
8.20	(4) examine laws, policies, and procedures in other states related to enforcing orders
8.21	requiring the surrender of firearms;
8.22	(5) identify barriers to enforcing orders in Minnesota that require the surrender of firearms
8.23	by individuals subject to an order for protection or convicted of domestic assault, harassment,
8.24	or stalking;
8.25	(6) identify best practices for enforcing orders requiring the surrender of firearms,
8.26	prioritizing practices that protect the safety of peace officers, prosecutors, judges and court
8.27	staff, victims, and others;
8.28	(7) identify policies and procedures that reduce the danger to peace officers and other
8.29	emergency responders called to an incident involving domestic violence; and
8.30	(8) make policy and funding recommendations to the legislature.
8.31	(b) At its discretion, the task force may examine other issues consistent with this section.

- 9.1 Subd. 5. Recommendations; report. The task force may issue recommendations and
- 9.2 reports at any time during its existence. By February 1, 2025, the task force must submit a
- 9.3 report to the chairs and ranking minority members of the house of representatives and senate
- 9.4 <u>committees and divisions with jurisdiction over public safety finance and policy on the</u>
- 9.5 <u>findings and recommendations of the task force.</u>
- 9.6 Subd. 6. Expiration. The task force expires the day after submitting its report under
- 9.7 <u>subdivision 5.</u>
