RE: Please support early childhood mental health

Dear Chairs Abeler, Benson, Fischer, Liebling, Pinto, and Schultz:

We are a group of child advocates respectfully requesting that your committees on health, human services, and early childhood come together to support early childhood mental health this session.

Specifically, we hope the legislature will **adopt the early childhood policy provisions proposed as part of the Uniform Service Standards package** from Minnesota DHS, including the use of the DC:-5 diagnostic classification tool.

Simply put, clinical tools for adults are not the right ones to use with young children. The social, emotional, and developmental challenges that appear in the first years of life can have a particularly high overlap in symptoms. One example is that trauma often can appear to be similar to anxiety or other disorders in some young children. But, the treatment approaches are markedly different for the different diagnoses. It takes a trained clinician using the right tools to be able to identify the right diagnosis — which then makes it possible to select the most effective early intervention.

The DC:0-5 tool has nationwide support and is the only diagnostic tool specifically developed for and validated with young children. Having more clinicians in Minnesota using it is an important part of building the early childhood mental health system, and it will reinforce other investments the Legislature continues to make in evidence-based early childhood practices like Attachment Bio-Behavioral Catch-up, Parent-Child Interactive Therapy, and Early Childhood Consultation.

Therefore, we ask you to please support the early childhood mental health policy language this year.
