2.8 (5) as necessary, provide for assessment of potential threats to life or safety of a principal
2.9 state official and develop individualized plans for personal protective services of a principal
2.10 state official;

2.11 (6) review and provide input on plans by political subdivisions and local law enforcement
2.12 agencies for security services provided to principal state officials;

2.13 (7) upon written or electronic request of the speaker of the house or the majority leader
2.14 of the senate, provide security and protection to either or both houses of the legislature or
2.15 for any legislative proceeding or event, including but not limited to a meeting of the senate
2.16 or house of representatives, committee hearing, press conference, or private caucus meeting;
2.17 and

2.18 (8) perform other activities determined to be necessary and related to the duties specified
2.19 in this subdivision, after consultation with the commissioner and the governor.

2.20 (c) The duties of the protective services unit do not include direct personal protective
2.21 services or emergency response outside the Capitol complex, except in the performance of
2.22 mutual aid arrangements or agreements or as supplemental support in coordination with a
2.23 local law enforcement agency.

2.24 (d) The commissioner may provide security and protection under paragraph (b), clause
2.25 (7), in the form and manner the commissioner deems necessary.

2.26 (e) The protocols and procedures under paragraph (b) must follow generally accepted
2.27 practices for security and protective service information gathering and evaluation and must
2.28 safeguard the due process rights, civil liberties, and privacy rights of individuals."

3.5 state government, public safety, and transportation and to the Advisory Committee on
3.6 Capitol Area Security. At a minimum, the report must:

3.7 (1) provide a status update on implementation of the protective services unit under
3.8 Minnesota Statutes, section 299E.10;

3.9 (2) summarize the activities of the protective services unit in each of the duties specified
3.10 under Minnesota Statutes, section 299E.10, subdivision 3;

3.11 (3) provide the plan required under Minnesota Statutes, section 299E.10, subdivision 3,
3.12 paragraph (b), clause (5); and

3.13 (4) make recommendations on any relevant changes in state law, including proposed
3.14 legislation.
