1.3 "Sec. .... Minnesota Statutes 2022, section 256.962, subdivision 5, is amended to read:

1.4 Subd. 5. **Incentive program.** Beginning January 1, 2008, the commissioner shall establish  
1.5 an incentive program for organizations and licensed insurance producers under chapter 60K  
1.6 that directly identify and assist potential enrollees in filling out and submitting an application.  
1.7 For each applicant who is successfully enrolled in MinnesotaCare or medical assistance,  
1.8 the commissioner, within the available appropriation, shall pay the organization or licensed  
1.9 insurance producer a ~~\$70~~ \$100 application assistance bonus. The organization or licensed  
1.10 insurance producer may provide an applicant a gift certificate or other incentive upon  
1.11 enrollment.

1.12 **EFFECTIVE DATE.** This section is effective July 1, 2023."

2.20 with a MNsure grant services navigator assister contract in good standing as of June 30,  
2.21 2023. The grant payment to each organization must be in proportion to the number of medical  
2.22 assistance and MinnesotaCare enrollees each organization assisted that resulted in a  
2.23 successful enrollment in the second quarter of fiscal years 2020 and 2022, as determined  
2.24 by MNsure's navigator payment process. Funds are available until expended. This is a  
2.25 onetime appropriation.

2.26 "(b) \$36,000,000 in fiscal year 2024 is appropriated from the health care access fund to  
2.27 the commissioner of human services for grants to counties to assist with unwinding the  
2.28 public health emergency.

2.29 "(c) \$5,000,000 in fiscal year 2024 is appropriated from the health care access fund to  
2.30 the commissioner of human services for outreach efforts related to unwinding the public  
2.31 health emergency.

3.1 (d) \$1,470,000 in fiscal year 2024 and \$1,470,000 in fiscal year 2025 are appropriated  
3.2 from the health care access fund to the commissioner of human services to increase the  
3.3 application assistance bonus for navigators. The health care access fund base for this  
3.4 appropriation is \$1,470,000 in fiscal year 2026 and \$1,470,000 in fiscal year 2027."
