

SRA: State Recreation Area


WMA: Wildlife Management Area

#### • DNR is in all 87 counties. This includes:

- 5.6 million acres of land
- 2,924 buildings
  - 234 work sites (map to left)
  - About 30,000 building components
- DNR "built" assets are valued at about \$3.5 billion (Current Replacement Value)



# **DNR 2023 Bonding Overview**



# **DNR 2023 Bonding Overview**

- Preserve existing assets (Natural Resources Asset Preservation): \$133 million
- Meet new or changed facility and infrastructure needs (Betterment of Buildings): \$43.7 million
- Invest in public lands (Acquisition and Betterment of Public Lands): \$18 million
- Wildfire Aviation Infrastructure: \$9.4 million
- State land accessibility: \$6 million
- Dam safety repair, reconstruction, or removal: \$9.6 million

- Flood Hazard Mitigation Grant Assistance: \$24 million
- Lake Vermilion-Soudan Underground Mine State Park: \$14.4 million
- Parks and trails local and regional grants: \$1.2 million
- Community tree planting grants: \$6 million
- Administration of local project grants and Upper Sioux Agency State Park bond defeasance: \$454,000

#### Total Investment: \$265.7 million



# Preserve and Rehabilitate Existing Assets

- Buildings and building components
- Public water accesses
- Roads, bridges and trails
- Fish hatchery infrastructure
- Water and wastewater systems
- Wildfire aviation infrastructure
- Dam safety repair, reconstruction or removal







#### Invest in Public Lands and Facilities to Meet Current and Future Needs

- Modernize existing facilities and invest in new facilities, including:
  - Hibbing Drill Core Library
  - Waterville Fish Hatchery
  - State Forest Nursery
- Acquire high-priority parcels and improve existing state lands, including:
  - Reforestation
  - New shorefishing opportunities
  - Enhanced access
- Comprehensive accessibility improvements
- Continued development of Lake Vermillion-Soudan Underground Mine State Park


