3.7 agreeing to practice in designated rural areas or underserved urban communities or
3.8 specializing in the area of pediatric psychiatry;

3.9 (2) for midlevel practitioners agreeing to practice in designated rural areas or to teach
3.10 at least 12 credit hours, or 720 hours per year in the nursing field in a postsecondary program
