1.6	Section 1. Minnesota Statutes 2024, section 171.13, subdivision 1, is amended to read:
1.7	Subdivision 1. Examination subjects and locations; provisions for color blindness,
1.8	disabled veterans. (a) Except as otherwise provided in this section, the commissioner must
1.9	examine each applicant for a driver's license by such agency as the commissioner directs.
1.10	This examination must include:
1.11	(1) a test of the applicant's eyesight, provided that this requirement is met by submission
1.12	of a vision examination certificate under section 171.06, subdivision 7;
1.13	(2) a test of the applicant's ability to read and understand highway signs regulating,
1.14	warning, and directing traffic;
1.15	(3) a test of the applicant's knowledge of (i) traffic laws; (ii) the effects of alcohol and
1.16	drugs on a driver's ability to operate a motor vehicle safely and legally, and of the legal
1.17	penalties and financial consequences resulting from violations of laws prohibiting the
1.18	operation of a motor vehicle while under the influence of alcohol or drugs; (iii) railroad
1.19	grade crossing safety; (iv) slow-moving vehicle safety; (v) laws relating to pupil

 applicant is eligible to take the examination.
- (e) The commissioner must provide real-time information on the department's website 2.17 about the availability and location of exam appointments. The website must show the next 2.18 available exam dates and times for each exam station. The website must also provide an 2.19 option for a person to enter an address to see the date and time of the next available exam 2.20 at each exam station sorted by distance from the address provided. The commissioner must 2.21 make at least 50 percent of projected appointments available to book three months in advance, 2.22 75 percent of projected appointments available to book two months in advance, and 100 2.23 percent of projected appointments available to book one month in advance. 2.24

Subd. 7. Examination fees. (a) A fee of \$10 must be paid by an individual to take a
third and any subsequent knowledge test administered by the department if the individual
has failed two previous consecutive knowledge tests on the subject.

(b) A fee of \$20 must be paid by an individual to take a third and any subsequent skills
or road test administered by the department if the individual has previously failed two
consecutive skill or road tests in a specified class of motor vehicle.
