

1.1 Section 1. Minnesota Statutes 2022, section 119A.52, is amended to read:

1.2 **119A.52 DISTRIBUTION OF APPROPRIATION.**

1.3 (a) The commissioner of education must distribute money appropriated for that purpose
1.4 to federally designated Head Start programs to expand services and to serve additional
1.5 low-income children. ~~Migrant and Indian reservation programs must be initially allocated~~
1.6 ~~money based on the programs' share of federal funds.,~~ which may include costs associated
1.7 with program operations, infrastructure, or reconfiguration to serve children from birth to
1.8 age five in center-based services. The distribution must occur in the following order: (1)
1.9 10.72 percent of the total Head Start appropriation must be initially allocated to federally
1.10 designated Tribal Head Start programs; (2) the Tribal Head Start portion of the appropriation
1.11 must be initially allocated to Tribal Head Start programs based on the programs' share of
1.12 federal funds; and (3) migrant programs must be initially allocated funding based on the
1.13 programs' share of federal funds. The remaining money must be initially allocated to the
1.14 remaining local agencies based equally on the agencies' share of federal funds and on the
1.15 proportion of eligible children in the agencies' service area who are not currently being
1.16 served. A Head Start program must be funded at a per child rate equal to its contracted,
1.17 federally funded base level at the start of the fiscal year. For all agencies without a federal
1.18 Early Head Start rate, the state average federal cost per child for Early Head Start applies.
1.19 In allocating funds under this paragraph, the commissioner of education must assure that
1.20 each Head Start program in existence in 1993 is allocated no less funding in any fiscal year
1.21 than was allocated to that program in fiscal year 1993. Before paying money to the programs,
1.22 the commissioner must notify each program of its initial allocation and how the money must
1.23 be used. Each program must present a plan under section 119A.535. For any program that
1.24 cannot utilize its full allocation at the beginning of the fiscal year, the commissioner must
1.25 reduce the allocation proportionately. Money available after the initial allocations are reduced
1.26 must be redistributed to eligible programs.

1.27 (b) The commissioner must develop procedures to make payments to programs based
1.28 upon the number of children reported to be enrolled during the required time period of
1.29 program operations. Enrollment is defined by federal Head Start regulations. The procedures
1.30 must include a reporting schedule, corrective action plan requirements, and financial
1.31 consequences to be imposed on programs that do not meet full enrollment after the period
1.32 of corrective action. Programs reporting chronic underenrollment, as defined by the
1.33 commissioner, will have their subsequent program year allocation reduced proportionately.
1.34 Funds made available by prorating payments and allocations to programs with reported

2.1 underenrollment will be made available to the extent funds exist to fully enrolled Head Start
2.2 programs through a form and manner prescribed by the department.

2.3 (c) Programs with approved innovative initiatives that target services to high-risk
2.4 populations, including homeless families and families living in homeless shelters and
2.5 transitional housing, are exempt from the procedures in paragraph (b). This exemption does
2.6 not apply to entire programs. The exemption applies only to approved innovative initiatives
2.7 that target services to high-risk populations, including homeless families and families living
2.8 in homeless shelters, transitional housing, and permanent supportive housing.

2.9 **Sec. 2. [119C.01] GREAT START SCHOLARSHIPS PROGRAM.**

2.10 Subdivision 1. Establishment; purpose. The commissioner of children, youth, and
2.11 families, in collaboration with the commissioner of education and the commissioner of
2.12 human services, shall develop and, to the extent funds are available and notwithstanding
2.13 federal and state laws to the contrary, implement a plan for the great start scholarships
2.14 program to ensure affordable access to high-quality early care and learning for children
2.15 from birth to kindergarten entry.

2.16 Subd. 2. Development. In developing the plan and implementing the program under
2.17 this section, the commissioner shall:

2.18 (1) identify ways to integrate the functions, administrative structures, and funding
2.19 mechanisms of early care and learning programs administered by the state with the great
2.20 start scholarships program;

2.21 (2) consider the recommendations made by the Great Start for All Minnesota Children
2.22 Task Force under Laws 2021, First Special Session chapter 7, article 14, section 18,
2.23 subdivision 2;

2.24 (3) create a process and timeline to transition the following families to the great start
2.25 scholarships program by July 1, 2028:

2.26 (i) families with at least one child receiving an early learning scholarship under section
2.27 124D.165; and

2.28 (ii) families with at least one child who is not yet in kindergarten and is receiving child
2.29 care assistance under section 119B.03 or 119B.05 for care received from a provider licensed
2.30 under Minnesota Rules, chapter 9502 or 9503, or Tribally licensed, or a Head Start program
2.31 that has a rating under section 124D.142;

3.1 (4) create mechanisms for members of local communities, including families and members
3.2 of the early care and learning workforce, to have input in decisions regarding needs and
3.3 preferences for early care and learning options;

3.4 (5) develop a proposed method for funding early care and learning slots in response to
3.5 local need through contracts with eligible providers that may be used to deliver services
3.6 that meet quality and compensation standards with the intent to build early care and learning
3.7 capacity statewide for children from birth to kindergarten entry; and

3.8 (6) consider how to maximize available federal resources while maintaining access to
3.9 child care assistance funding under sections 119B.03 and 119B.05 for school-age children.
3.10 The commissioner, in consultation with an appropriate state agency, may seek federal
3.11 technical assistance or outside consultation as necessary to provide minimally burdensome
3.12 program access to all participating families.

3.13 Subd. 3. Program requirements. The great start scholarships program must include at
3.14 a minimum:

3.15 (1) a method to provide financial assistance to families voluntarily participating in the
3.16 program;

3.17 (2) family eligibility for any qualifying family that has at least one child who is not yet
3.18 in kindergarten;

3.19 (3) provider eligibility for:

3.20 (i) any program licensed under Minnesota Rules, chapter 9502 or 9503, or Tribally
3.21 licensed, that participates in the quality rating and improvement system under section
3.22 124D.142; and

3.23 (ii) any school-based program and Head Start program that has a rating under section
3.24 124D.142;

3.25 (4) a unified, integrated, and simple online application process that utilizes administrative
3.26 data to ease qualification and benefit determination and meet federal reporting requirements;

3.27 (5) an electronic attendance tracking system that is integrated, to the extent practicable,
3.28 and payments system to safeguard program integrity and streamline billing and payment
3.29 processes for providers; and

3.30 (6) a schedule for family contributions and provider payments that ensures that no
3.31 participating family pays more than seven percent of annual income for early care and
3.32 learning services for children from birth to kindergarten entry. Family contributions and

4.1 provider payments may vary by family income, program quality, geography, and need for
 4.2 compensatory services, and may take into consideration the results of the market rate survey
 4.3 under section 119B.02, subdivision 7; information from cost estimation models for providing
 4.4 early care and learning in the state; and cost information gathered through contracts under
 4.5 subdivision 2, clause (5).

4.6 Subd. 4. **Administration; reporting requirement.** (a) By July 1, 2028, to the extent
 4.7 funding is appropriated and notwithstanding federal and state laws to the contrary, the
 4.8 commissioner shall have in place the administrative structures and systems needed for the
 4.9 great start scholarships program to meet the operational needs of participating families and
 4.10 eligible providers.

4.11 (b) By July 1, 2026, the commissioner, in consultation with the commissioners of
 4.12 education and human services, must submit a report to the legislative committees with
 4.13 jurisdiction over early care and learning on the status of planning for the program under
 4.14 this section. The report must:

4.15 (1) include information on progress made and work underway to develop the program;

4.16 (2) provide details about the administrative structures, systems, and funding needed to
 4.17 meet the needs of families and providers who may participate in the program; and

4.18 (3) identify any statutory or regulatory changes necessary for implementation of the
 4.19 program.

4.20 Sec. 3. Minnesota Statutes 2022, section 121A.17, subdivision 3, is amended to read:

4.21 Subd. 3. **Screening program.** (a) A screening program must include at least the following
 4.22 components: developmental assessments, including virtual developmental screening for
 4.23 families who make the request based on their immunocompromised health status or other
 4.24 health conditions, hearing and vision screening or referral, immunization review and referral,
 4.25 the child's height and weight, the date of the child's most recent comprehensive vision
 4.26 examination, if any, identification of risk factors that may influence learning, an interview
 4.27 with the parent about the child, and referral for assessment, diagnosis, and treatment when
 4.28 potential needs are identified. The district and the person performing or supervising the
 4.29 screening must provide a parent or guardian with clear written notice that the parent or
 4.30 guardian may decline to answer questions or provide information about family circumstances
 4.31 that might affect development and identification of risk factors that may influence learning.
 4.32 The notice must state "Early childhood developmental screening helps a school district
 4.33 identify children who may benefit from district and community resources available to help

5.1 in their development. Early childhood developmental screening includes a vision screening
5.2 that helps detect potential eye problems but is not a substitute for a comprehensive eye
5.3 exam." The notice must clearly state that declining to answer questions or provide information
5.4 does not prevent the child from being enrolled in kindergarten or first grade if all other
5.5 screening components are met. If a parent or guardian is not able to read and comprehend
5.6 the written notice, the district and the person performing or supervising the screening must
5.7 convey the information in another manner. The notice must also inform the parent or guardian
5.8 that a child need not submit to the district screening program if the child's health records
5.9 indicate to the school that the child has received comparable developmental screening
5.10 performed within the preceding 365 days by a public or private health care organization or
5.11 individual health care provider. The notice must be given to a parent or guardian at the time
5.12 the district initially provides information to the parent or guardian about screening and must
5.13 be given again at the screening location.

5.14 (b) All screening components shall be consistent with the standards of the state
5.15 commissioner of health for early developmental screening programs. A developmental
5.16 screening program must not provide laboratory tests or a physical examination to any child.
5.17 The district must request from the public or private health care organization or the individual
5.18 health care provider the results of any laboratory test or physical examination within the 12
5.19 months preceding a child's scheduled screening. For the purposes of this section,
5.20 "comprehensive vision examination" means a vision examination performed by an optometrist
5.21 or ophthalmologist.

5.22 (c) If a child is without health coverage, the school district must refer the child to an
5.23 appropriate health care provider.

5.24 (d) A board may offer additional components such as nutritional, physical and dental
5.25 assessments, review of family circumstances that might affect development, blood pressure,
5.26 laboratory tests, and health history.

5.27 (e) If a statement signed by the child's parent or guardian is submitted to the administrator
5.28 or other person having general control and supervision of the school that the child has not
5.29 been screened because of conscientiously held beliefs of the parent or guardian, the screening
5.30 is not required.

6.1 Sec. 4. Minnesota Statutes 2022, section 121A.19, is amended to read:

6.2 **121A.19 DEVELOPMENTAL SCREENING AID.**

6.3 Each school year, the state must pay a district for each child or student screened by the
 6.4 district according to the requirements of section 121A.17. The amount of state aid for each
 6.5 child or student screened shall be: (1) ~~\$75~~ \$98 for a child screened at age three; (2) ~~\$50~~ \$65
 6.6 for a child screened at age four; (3) ~~\$40~~ \$52 for a child screened at age five or six prior to
 6.7 kindergarten; and (4) ~~\$30~~ \$39 for a student screened within 30 days after first enrolling in
 6.8 a public school kindergarten if the student has not previously been screened according to
 6.9 the requirements of section 121A.17. If this amount of aid is insufficient, the district may
 6.10 permanently transfer from the general fund an amount that, when added to the aid, is
 6.11 sufficient. Developmental screening aid shall not be paid for any student who is screened
 6.12 more than 30 days after the first day of attendance at a public school kindergarten, except
 6.13 if a student transfers to another public school kindergarten within 30 days after first enrolling
 6.14 in a Minnesota public school kindergarten program. In this case, if the student has not been
 6.15 screened, the district to which the student transfers may receive developmental screening
 6.16 aid for screening that student when the screening is performed within 30 days of the transfer
 6.17 date.

6.18 Sec. 5. **122A.261 PREKINDERGARTEN, SCHOOL READINESS, PRESCHOOL,**
 6.19 **AND EARLY EDUCATION PROGRAMS; LICENSURE REQUIREMENT.**

6.20 Subdivision 1. Licensure requirement. (a) A school district or charter school must
 6.21 employ a qualified teacher, as defined in section 122A.16, to provide instruction in a
 6.22 preschool, school readiness, school readiness plus, or prekindergarten program or other
 6.23 school district or charter school-based early education program.

6.24 (b) This subdivision does not apply to individuals providing instruction in a child care
 6.25 center licensed under Minnesota Rules, chapter 9503, or in a certified license-exempt child
 6.26 care center under chapter 245H.

6.27 Subd. 2. Exemptions. Any teacher who has taught in a preschool, school readiness,
 6.28 school readiness plus, or prekindergarten program, or other early learning program for at
 6.29 least five years prior to September 1, 2028, may continue to teach without obtaining a
 6.30 license. Notwithstanding this exemption from the licensure requirement, these individuals
 6.31 are teachers under section 179A.03, subdivision 18.

6.32 **EFFECTIVE DATE.** This section is effective July 1, 2028.

7.1 Sec. 6. [122A.731] GRANTS FOR GROW YOUR OWN EARLY CHILDHOOD
 7.2 AND FAMILY EDUCATOR PROGRAMS.

7.3 Subdivision 1. **Establishment.** The commissioner of education must award grants for
 7.4 Grow Your Own Early Childhood Educator programs established under this section in order
 7.5 to develop an early childhood education workforce that more closely reflects the state's
 7.6 increasingly diverse student population and ensures all students have equitable access to
 7.7 high-quality early educators.

7.8 Subd. 2. **Grow Your Own Early Childhood and Family Educator programs.** (a)
 7.9 Minnesota-licensed family child care or licensed center-based child care programs, school
 7.10 district or charter school early learning programs, Head Start programs, institutions of higher
 7.11 education, and other community partnership nongovernmental organizations may apply for
 7.12 a grant to host, build, or expand an early childhood educator preparation program that leads
 7.13 to an individual earning the credential or degree needed to enter or advance in the early
 7.14 childhood education workforce. Examples include programs that help interested individuals
 7.15 earn the child development associate (CDA) credential, an associate's degree in child
 7.16 development, or a bachelor's degree in early childhood and family education studies or early
 7.17 childhood licensures. The grant recipient must use at least 80 percent of grant money for
 7.18 student stipends, tuition scholarships, or unique student teaching or field placement
 7.19 experiences.

7.20 (b) Programs providing financial support to interested individuals may require a
 7.21 commitment from the individuals awarded, as determined by the commissioner, to teach in
 7.22 the program or school for a reasonable amount of time that does not exceed one year.

7.23 Subd. 3. **Grant procedure.** (a) Eligible programs must apply for a grant under this
 7.24 section in the form and manner specified by the commissioner. To the extent that there are
 7.25 sufficient applications, the commissioner must, to the extent practicable, award an equal
 7.26 number of grants between applicants in greater Minnesota and those in the metropolitan
 7.27 area.

7.28 (b) For the 2023-2024 school year and later, grant applications for new and existing
 7.29 programs must be received by the commissioner no later than January 15 of the year prior
 7.30 to the school year in which the grant will be used. The commissioner must review all
 7.31 applications and notify grant recipients by March 15 or as soon as practicable of the
 7.32 anticipated amount awarded. If the commissioner determines that sufficient funding is
 7.33 unavailable for the grants, the commissioner must notify grant applicants by June 30 or as
 7.34 soon as practicable that there is insufficient money.

8.1 Subd. 4. **Grow Your Own Early Childhood Education program account.** (a) The
8.2 Grow Your Own Early Childhood Education program account is established in the special
8.3 revenue fund.

8.4 (b) Money appropriated for the Grow Your Own Early Childhood Education program
8.5 under this section must be transferred to the Grow Your Own Early Childhood Education
8.6 program account in the special revenue fund.

8.7 (c) Money in the account is annually appropriated to the commissioner for the Grow
8.8 Your Own Early Childhood Education program under this section. Any returned money is
8.9 available to be regranted. Grant recipients may apply to use grant money over a period of
8.10 up to 60 months.

8.11 (d) Up to \$175,000 annually is appropriated to the commissioner for costs associated
8.12 with administering and monitoring the program under this section.

8.13 Subd. 5. **Report.** Grant recipients must annually report to the commissioner in the form
8.14 and manner determined by the commissioner on their activities under this section, including
8.15 the number of educators supported through grant money and the number of educators
8.16 obtaining credentials by type. Data must indicate the beginning level of education and ending
8.17 level of education of individual participants and an assessment of program effectiveness,
8.18 including participant feedback, areas for improvement, and employment changes and current
8.19 employment status, where applicable, after completing preparation programs. The
8.20 commissioner must publish a report for the public that summarizes the activities and
8.21 outcomes of grant recipients and what was done to promote sharing of effective practices
8.22 among grant recipients and potential grant applicants.

8.23 Sec. 7. Minnesota Statutes 2022, section 124D.13, is amended by adding a subdivision to
8.24 read:

8.25 Subd. 12a. **Support staff.** (a) The department must employ two full-time equivalent
8.26 staff to serve as resources for programs described in this section. The staff persons must
8.27 provide operational support and guidance to programs, including but not limited to providing
8.28 professional development and education support, assisting with marketing and outreach,
8.29 and facilitating collaborations with public and private organizations serving families.

8.30 (b) Each staff person described in this subdivision must hold a valid license as a teacher
8.31 of parent and family education.

9.1 Sec. 8. Minnesota Statutes 2022, section 124D.141, subdivision 2, is amended to read:

9.2 Subd. 2. **Additional duties.** The following duties are added to those assigned to the
9.3 council under federal law:

9.4 (1) make recommendations on the most efficient and effective way to leverage state and
9.5 federal funding streams for early childhood and child care programs;

9.6 ~~(2) make recommendations on how to coordinate or colocate early childhood and child
9.7 care programs in one state Office of Early Learning. The council shall establish a task force
9.8 to develop these recommendations. The task force shall include two nonexecutive branch
9.9 or nonlegislative branch representatives from the council; six representatives from the early
9.10 childhood caucus; two representatives each from the Departments of Education, Human
