

1.1 ..... moves to amend H.F. No. 3486 as follows:

1.2 Page 2, after line 22, insert:

1.3 "Sec. 2. [168.1262] FOOD BANKS PLATES.

1.4 Subdivision 1. Issuance of plates. The commissioner must issue Minnesota food banks  
1.5 special license plates or a single motorcycle plate to an applicant who:

1.6 (1) is a registered owner of a passenger automobile, noncommercial one-ton pickup  
1.7 truck, motorcycle, or recreational vehicle;

1.8 (2) pays a fee in the amount specified for special plates under section 168.12, subdivision  
1.9 5, along with any other fees required under this chapter;

1.10 (3) pays the registration tax as required under section 168.013;

1.11 (4) contributes a minimum of \$40 annually to the food bank assistance account; and

1.12 (5) complies with this chapter and rules governing registration of motor vehicles and  
1.13 licensing of drivers.

1.14 Subd. 2. Design. The commissioner, in consultation with the commissioner of children,  
1.15 youth, and families, must adopt a suitable plate design that includes the inscription "Support  
1.16 Food Banks."

1.17 Subd. 3. Plates transfer. On application to the commissioner and payment of a transfer  
1.18 fee of \$5, special plates issued under this section may be transferred to another motor vehicle  
1.19 if the subsequent vehicle is:

1.20 (1) qualified under subdivision 1, clause (1), to bear the special plates; and

1.21 (2) registered to the same individual to whom the special plates were originally issued.

2.1 Subd. 4. **Exemption.** Special plates issued under this section are not subject to section  
2.2 168.1293, subdivision 2.

2.3 Subd. 5. **Contributions; account; appropriations.** (a) Contributions collected under  
2.4 subdivision 1, clause (4), must be deposited as follows:

2.5 (1) 75 percent in the food bank assistance account, which is established in the special  
2.6 revenue fund; and

2.7 (2) 25 percent in the general fund.

2.8 (b) An amount necessary is appropriated from the food bank assistance account to the  
2.9 commissioner for the costs to administer the requirements of this section.

2.10 (c) After the appropriation in paragraph (b), the amount remaining in the account is  
2.11 appropriated to the commissioner of children, youth, and families for distribution to regional  
2.12 food banks and Tribal governments, as defined in section 10.65, subdivision 2, in accordance  
2.13 with the federal The Emergency Food Assistance Program (TEFAP) formula and United  
2.14 States Department of Agriculture guidelines. This appropriation is available for purchase,  
2.15 transport, and coordination of the distribution of food and personal hygiene products to  
2.16 individuals and families in need.

2.17 **EFFECTIVE DATE.** This section is effective January 1, 2027."
