1.2 Page 3, line 28, delete everything after "official" and insert "is presumed to be the county  
1.3 auditor if the county has adopted ranked choice voting. If an overlapping city and school  
1.4 district adopt ranked choice voting, the municipal clerk is presumed to be the ranked choice  
1.5 voting election official. Nothing in this subdivision prohibits overlapping jurisdictions from  
1.6 agreeing to an alternative ranked choice voting election official."

1.7 Page 3, delete lines 29 and 30

1.8 Page 5, after line 5, insert:

1.9 "Subd. 28. **Undeclared candidate.** "Undeclared candidate" means a candidate who does  
1.10 not file a request within the time required by section 204E.05, subdivision 4, for the  
1.11 candidate's write-in votes to be counted, and whose name does not otherwise appear on the  
1.12 ballot."

1.13 Page 5, line 9, after "2025," insert "or the adoption of administrative rules governing  
1.14 ranked choice voting by the secretary of state, whichever is later," and delete everything

1.18 Page 5, line 14, after "districts" insert "; and" and delete the period

1.19 Page 5, after line 14, insert:

1.20 "(3) counties."

1.21 Page 5, line 17, delete everything after the period

1.22 Page 5, delete lines 18 to 20 and insert:

2.1 "(c) Before adopting the use of ranked choice voting for an election held in conjunction  
2.2 with a statewide election, a jurisdiction must enter into an agreement, or a conditional  
2.3 agreement if adopting by ballot question, with the county or counties responsible for  
2.4 administering the jurisdiction's election.

2.5 (d) If a home rule charter or statutory city adopts ranked choice voting without an  
2.6 agreement with the county or counties, the election conducted by ranked choice voting must  
2.7 not be held in conjunction with a statewide election and the jurisdiction must administer its  
2.8 own election.

2.9 (e) Before a school district can adopt the use of ranked choice voting for an election not  
2.10 held in conjunction with a statewide election, the district must first enter into an agreement,  
2.11 or a conditional agreement if adopting by ballot question, with the city or cities within the  
2.12 district's boundaries responsible for administering any elections conducted not in conjunction  
2.13 with a statewide election."

3.5 voting tabulation center as soon as possible after the vote counting is completed and the  
3.6 election judges have returned materials pursuant to section 204C.27."

4.2 number of federal office only absentee ballots and, if applicable, the number of presidential

4.24 chapter 204E must provide a test lab report from a voting system test lab accredited by the  
4.25 Election Assistance Commission or other appropriate federal agency responsible for testing  
4.26 and certification of compliance with the federal voting systems guidelines at the time of  
4.27 submission of the application required by subdivision 1. The test lab report must show that  
4.28 the system is in conformity with voluntary voting system guidelines issued by the Election  
4.29 Assistance Commission or other appropriate federal agency."

5.4 "Sec. .... Minnesota Statutes 2023 Supplement, section 206.83, is amended to read:

5.5 **206.83 TESTING OF VOTING SYSTEMS.**

5.6 (a) At least three days before voting equipment is used, the official in charge of elections  
5.7 shall have the voting system tested to ascertain that the system will correctly mark ballots  
5.8 using all methods supported by the system, including ranked choice voting if applicable,  
5.9 and through assistive technology, and count the votes cast for all candidates and on all  
5.10 questions. Public notice of the time and place of the test must be given at least two days in  
5.11 advance by publication once in official newspapers. The test must be observed by at least  
5.12 two election judges, who are not of the same major political party, and must be open to  
5.13 representatives of the political parties, candidates, the press, and the public. The test must  
5.14 be conducted by (1) processing a preaudited group of ballots punched or marked to record  
5.15 a predetermined number of valid votes for each candidate and on each question, and must  
5.16 include for each office one or more ballot cards which have votes in excess of the number  
5.17 allowed by law in order to test the ability of the voting system tabulator and electronic ballot  
5.18 marker to reject those votes; and (2) processing an additional test deck of ballots marked  
5.19 using the electronic ballot marker for the precinct, including ballots marked using the  
5.20 electronic ballot display, audio ballot reader, and any assistive voting technology used with  
5.21 the electronic ballot marker. If an election is to be conducted using ranked choice voting,  
5.22 the equipment must also be tested to ensure that each ranking for each candidate is recorded  
5.23 properly.

5.24 (b) If any error is detected, the cause must be ascertained and corrected and an errorless  
5.25 count must be made before the voting system may be used in the election.

5.26 (c) After the completion of the test, the programs used and ballot cards must be sealed,  
5.27 retained, and disposed of as provided for paper ballots."
