Bill Description

Fire Marshal

The Hometown Heroes Assistance Program was established during the 2021 legislative session to fun critical illness coverage to provide monetary support to firefighters diagnosed with a critical illness, develop a psychotherapy program customized to address emotional trauma experienced by firefighters, coordinate additional psychotherapy sessions for firefighters, develop/update/provide annual training to firefighters on critical illness such as cancer, heart disease and emotional trauma and provide for administrative and overhead costs for the program.

SF 2634 provides language to clarify participation in Hometown Heroes Act and transferring money to amend Laws 2021, First Special Session chapter 11, article 2 section 12.

SF 2634 transfers the Hometown Heroes Assistance Program from the Department of Public Safety Office of Justice Programs to the State Fire Marshall's Office and expands eligibility for the program.

Assumptions

Fire Marshal

That as long as the Hometown Heroes Assistance Program is in place, the State Fire Marshal Division (SFMD) will be the fiscal agent to distribute funds to the Minnesota Firefighter Initiative.

Office of Justice Program(OJP)

DPS-OJP assumes that the bill will transfer any remaining amounts from the state fiscal year 2022 appropriation to the State Fire Marshal's office for grants to the Minnesota Firefighter Initiative to fund the Hometown Heroes Assistance

Program. The amount listed on page 1 is an estimate of what will be remaining to transfer

Expenditure and/or Revenue Formula

Fire Marshal

The funds would be appropriated to the Commissioner of Public Safety and allocated to the State Fire Marshal Division. SFMD would grant out the funds to the Minnesota Firefighter Initiative to support these activities. Administrative costs for this initiative will be absorbed by the agency. MnFIRE will have administrative costs of their own which are included in the total budget for the program (see below).

The total budget for the Hometown Heroes program is \$4.0 million. These funds are budgeted as follows:

\$2.2 million to statewide critical care insurance (cardiac and cancer)

\$1.2 million to statewide MnFIRE Employee Assistance Program (MAP) which includes 5 EAP visits per firefighter \$200,000 statewide provider training to ensure they are familiar with firefighter specific mental health concerns \$200,000 MnFIRE training for fire departments statewide including awareness training and deeper dives into cardiac, cancer and mental trauma.

\$200,000 to MnFIRE to administer all aspects of the program including training, coordination of critical care insurance and MAP, connecting with providers for firefighter mental health concerns, and administer fire department training.

If funds become unavailable in the future, SFMD would not be able to support this program.
