1.7	Subd. 7. Institutions of public charity. (a) Institutions of purely public charity that are
1.8	exempt from federal income taxation under section 501(c)(3) of the Internal Revenue Code
1.9	are exempt if they meet the requirements of this subdivision. In determining whether real
1.10	property is exempt under this subdivision, the following factors must be considered:

A charitable organization must satisfy the factors in clauses (1) to (6) for its property to 2.3 be exempt under this subdivision, unless there is a reasonable justification for failing to 2.4 meet the factors in clause (2), (3), or (5), and the organization provides to the assessor the 2.5 factual basis for that justification. If there is reasonable justification for failing to meet the 2.6 factors in clause (2), (3), or (5), an organization is a purely public charity under this 2.7 subdivision without meeting those factors. After an exemption is properly granted under 2.8 this subdivision, it will remain in effect unless there is a material change in facts. 2.9

2.10 (b) For purposes of this subdivision, a grant is a written instrument or electronic document defining a legal relationship between a granting agency and a grantee when the principal 2.11 purpose of the relationship is to transfer cash or something of value to the grantee to support 2.12 a public purpose authorized by law in a general manner instead of acquiring by professional 2.13 or technical contract, purchase, lease, or barter property or services for the direct benefit or 2.14 use of the granting agency. 2.15

(c) Rental housing property does not qualify for an exemption under this subdivision 2.16

(c) (d) In determining whether rental housing property qualifies for exemption under 2.21 this subdivision, the following are not gifts or donations to the owner of the rental housing: 2.22

(1) rent assistance provided by the government to or on behalf of tenants; and 2.23

(2) financing assistance or tax credits provided by the government to the owner on 2.24 condition that specific units or a specific quantity of units be set aside for persons or families 2.25 with certain income characteristics. 2.26
