1.3 Page 64, delete lines 9 to 26 and insert:

1.4 "(2) oral buprenorphine to treat a substance use disorder;

1.5 (3) outpatient mental health treatment or outpatient substance use disorder treatment,
1.6 except for treatment which is: (i) a medication; and (ii) not otherwise listed in this
1.7 subdivision. Prior authorizations required for medications used for outpatient mental health
1.8 treatment or outpatient substance use disorder treatment, and not otherwise listed in this
1.9 subdivision, must be processed according to section 62M.05, subdivision 3b, for initial
1.10 determinations, and according to section 62M.06, subdivision 2, for appeals;

1.11 (4) antineoplastic cancer treatment that is consistent with guidelines of the National
1.12 Comprehensive Cancer Network, except for treatment which is: (i) a medication; and (ii)
1.13 not otherwise listed in this subdivision. Prior authorizations required for medications used
1.14 for antineoplastic cancer treatment, and not otherwise listed in this subdivision, must be
1.15 processed according to section 62M.05, subdivision 3b, for initial determinations, and
1.16 according to section 62M.06, subdivision 2, for appeals;

1.17 (5) services that currently have a rating of A or B from the United States Preventive
1.18 Services Task Force, immunizations recommended by the Advisory Committee on
1.19 Immunization Practices of the Centers for Disease Control and Prevention, or preventive
1.20 services and screenings provided to women as described in Code of Federal Regulations,
1.21 title 45, section 147.130;

1.22 (6) pediatric hospice services provided by a hospice provider licensed under sections
1.23 144A.75 to 144A.755; and

1.24 (7) treatment delivered through a neonatal abstinence program operated by pediatric
1.25 pain or palliative care subspecialists.

2.1 Clauses (2) to (7) are effective January 1, 2026, and apply to health benefit plans offered,
 2.2 sold, issued, or renewed on or after that date."

 2.13 associated conditions must not limit or exclude coverage for a drug approved by the United
 2.14 States Food and Drug Administration ~~that is on the health plan's prescription drug formulary~~
 2.15 by mandating that an enrollee with stage four advanced metastatic cancer or associated
 2.16 conditions obtain a prior authorization or follow a step therapy protocol if the use of the
 2.17 approved drug is consistent with:

2.18 (1) a United States Food and Drug Administration-approved indication; and

2.19 (2) a clinical practice guideline published by the National Comprehensive Care Network.
