1.7 to provide the educational programs offered;

1.8 (2) the school has financial resources sufficient to meet the school's financial obligations,
1.9 including refunding tuition and other charges consistent with its stated policy if the institution
1.10 is dissolved, or if claims for refunds are made, to provide service to the students as promised,
1.11 and to provide educational programs leading to degrees as offered;

1.12 (3) the school operates in conformity with generally accepted accounting principles
1.13 according to the type of school;

1.14 (4) the school provides an educational program leading to the degree it offers;
