Bill Description

Effective March 1, 2019, this bill increases the amount credited to the deer habitat improvement account (DHI) account from \$2 to \$16.00 for each annual deer license sold to persons18 years of age or older and decreases the amount credited to the Game and Fish operating account by the same amount.

Maintain current dedications, including \$2.00 dedication to DHI account, for resident and non-resident deer hunting licenses for persons age 13 or over and under age 18 to take deer with firearms, archery, and muzzleloaders.

Maintain current dedications, including \$2.00 dedication to DHI account, for deer bonus permits.

Maintain current dedications to the deer and bear account, wolf account, and emergency deer feeding and health account for all deer hunting licenses. Current dedications from the youth deer hunting licenses will also remain the same. This bill also removes the statutory appropriation authority to the commissioner from the DHI account.

Licenses impacted include:

- Resident and non-resident deer hunting licenses for persons over age 18 to take deer with firearms, archery, and muzzleloaders;
- Resident sports licenses that include taking deer by firearms, archery, or muzzleloader;
- Resident super sport licenses for individuals and married combination;
- Lifetime deer hunting licenses to take deer with firearms or archery which would transfer an amount equal to the amount that would otherwise have been collected from annual license fees.

Assumptions

Revised

Earnings based on similar licenses sales as sold in 2016/2017.

Assumes the current \$1.4 million budget in the deer habitat improvement (DHI) account will not be available to spend because language strikes the statutory authority to spend and does not provide a direct appropriation from this account.

Bill does not change the base appropriation to the Game and Fish Fund.

Estimated amount of revenue change is a decrease of (\$7.146M) from the Game and Fish operating account and an increase of \$7.146M to the DHI account with authority to spend only from the Game and Fish operating account.

Assumes youth lifetime license contribution of \$2 applies only to licenses for youth between the ages of 13 and 18 as outlined in Minnesota Statute 97A.075, subdivision 1.

Estimated revenues currently collected in the Game and Fish operating account between March 1, 2019 and June 30, 2019 total about \$147K. This FY19 revenue will be a decrease from the Game and Fish operating account and an increase to the DHI account.

Assumes no expense spending out of the DHI account after March 1, 2019 since the bill removes statutory authority and no funds have been appropriated. As a result, Fish and Wildlife may not be able to perform some core program activities unless other funding sources can be identified. Estimated expenditures during this time period total \$365K.

This note was prepared prior to the effective date of March 1, 2019. If the bill is enacted after March 1, 2019, the FY19 fiscal estimate would change. Please note that implementing this lanaguage retroacitvely would be administratively difficult.
