1.5 Subd. 3. **Evaluation and report.** (a) The Metropolitan Center for Independent Living
1.6 must contract with a third party to evaluate the pilot project's impact on health care costs,
1.7 retention of personal care assistants, and patients' and providers' satisfaction of care. The
1.8 evaluation must include the number of participants, the hours of care provided by participants,
1.9 and the retention of participants from semester to semester.

1.10 (b) By January 15, ~~2026~~ 2028, the Metropolitan Center for Independent Living must
1.11 report the findings under paragraph (a) to the chairs and ranking minority members of the
