2.10 Section 1. **APPROPRIATION.**

2.11 (a) \$..... in fiscal year 2020 and \$..... in fiscal year 2021 are appropriated from the
2.12 general fund to the commissioner of employment and economic development for a grant to
2.13 the Women's Foundation of Minnesota to create and administer a statewide internship
2.14 program for young women ages 17 through 24 who are American Indian, Asian, Black, or
2.15 Hispanic. This program shall connect participants with internships in the public, private,
2.16 and nonprofit sectors and subsidize intern wages. These funds are available until June 30,
2.17 2022.

2.18 (b) By January 15, 2022, the commissioner shall submit to the legislative committees
2.19 of the house of representative and the senate having jurisdiction over economic development
2.20 and workforce development policy and finance a report detailing the use of grant funds and
2.21 program outcomes. Where data is available, data in the report should be disaggregated by
2.22 race, cultural group, family income, geographic location, status as a migrant or foreign
2.23 immigrant, home language, English learners under Minnesota Statutes, section 124D.59,
2.24 disability, and status of homelessness."
