

1.1 moves to amend H.F. No. 1405, the delete everything amendment
1.2 (H1405DE1), as follows:

1.3 Page 3, after line 2, insert:

1.4 "Sec. 6. [216B.1697] ELECTRIC UTILITY REPORTS TO CUSTOMERS;
1.5 GENERATION SOURCES AND ENVIRONMENTAL IMPACTS.

1.6 (a) The commission must develop a uniform reporting format that all utilities providing
1.7 retail electric service to customers in Minnesota must use to report to customers as required
1.8 under this section.

1.9 (b) Beginning in 2021, and each year thereafter, A utility providing retail electric service
1.10 to customers in Minnesota must report annually the information required by this section for
1.11 the previous calendar year. The report must be included in an easily understood presentation
1.12 as part of a customer's monthly electric bill no later than April 1.

1.13 (c) The uniform reporting format developed by the commission must provide for reporting
1.14 of the following information for each calendar year:

1.15 (1) the average proportion of each technology or fuel source used to generate all electricity
1.16 sold at retail to the utility's Minnesota retail customers, including but not limited to coal,
1.17 natural gas, nuclear fuel, wind, solar, hydropower, solid waste incineration, and biomass.
1.18 Electricity purchased by a utility from the Midcontinent Independent System Operator must
1.19 reflect the system's average fuel mix during the calendar year;

1.20 (2) for each megawatt-hour of electricity sold by a utility to Minnesota retail customers,
1.21 the average number of pounds each of carbon dioxide, sulfur dioxide, and nitrogen oxides
1.22 released to the atmosphere as a result of generating the electricity. For electricity purchased
1.23 by a utility from the Midcontinent Independent System Operator, the commission must:

2.1 (i) determine default values for each pollutant listed in clause (2) per megawatt-hour of
2.2 electricity purchased;

2.3 (ii) share the default values with all utilities subject to this section; and

2.4 (iii) update the default values annually; and

2.5 (3) for each megawatt-hour of electricity sold by a utility to Minnesota retail customers
2.6 that is generated from nuclear fuel, the number of pounds of nuclear waste produced.

2.7 (d) Within 15 days after the date the information required under this section is distributed
2.8 with a customer's monthly bill, the utility compiling the information must place the
2.9 information on its website.

2.10 (e) A utility subject to this section must forward a copy of the information required under
2.11 this section to the commission. The commission must place the information on the
2.12 commission's website and must update the information as necessary.

2.13 **EFFECTIVE DATE; APPLICATION.** This section is effective the day following
2.14 final enactment. The commission must develop the uniform reporting format required under
2.15 this section no later than January 1, 2021."
